Mode of Selection: Selection will be made based on **Interview online** (through MS Team/Skype/ etc.) The date of the interview will be notified separately on the **www.neeri.res.in website**.

1. The above positions are purely temporary and co-terminus with the aforementioned projects. The engagement in these projects will not confer any right implicit or explicit on the candidate for consideration regularization against any CSIR/CSIR - NEERI post(s). Moreover, under no circumstances the tenure of project staff who have served CSIR-NEERI or any other laboratories/Institutes of CSIR under contract R&D projects would be allowed to exceed Six or Seven years as the case may be as per clause no. 1.6/1.7 of CSIR OM No. 5-1(342)/2017-PD Dated 02.09.2024 as amended from time to time.
2. Upper age limit shall be reckoned as on the last date of receipt of applications
3. Candidates are not required to pay any application fees.
4. Only those candidates who have acquired the essential qualification & result has been declared (should have at least a provisional certificate) are eligible to apply for a particular position.
5. Result awaited /Final semester appeared or Ph. D submitted candidates are not eligible to apply for the position where such minimum essential qualification requirement is mandatory.
6. Final semester and result awaited candidates are not allowed to appear for the interview.

7. Experience, where required, will be counted from the date after acquiring minimum educational qualification. Dissertation/ Thesis work done during the academic period will not be counted as experience.
8. Time spent in acquiring higher qualifications will not be counted as an experience over an essential qualification.
9. Mere fulfilling of minimum qualification does not confer any right on a candidate to be called for an interview. If a large number of applications are received, preference will be given to the candidates under the criteria adopted by the Screening Committee.
10. The shortlisted candidates may be invited for the online interview; information will be uploaded on the website/ portal. **(applicable only for online interviews)**
11. No upgradation of the project staff shall be done in same or new project. However, candidates have to apply fresh, and if shortlisted, may have to appear for the interview.
12. CSIR-NEERI reserves the right to cancel or withdraw the offer of engagement in case of any discrepancy found, in the candidature of any empaneled candidate at any stage.
13. The selected candidates are expected to join within the time frame mentioned in the offer letter from the date of receiving the offer letter of appointment, after completion of pre-appointment formalities like medical examination, character verification, etc.
14. Engagement under the new project would be made only after the acceptance of the resignation from the previous project by the competent authority.
15. Engagement of project staff will depend on the project tenure/requirement, which may be extended or curtailed depending on the duration of the Project/desired level performance or conduct of the incumbent, as the case may be.
16. The engagement of project staff may be terminated at any time without assigning any reasons, by giving a one-month notice. In case, the person desires to leave the assignment, he/she may also do so by giving one month's notice or payment of one-month remuneration instead of, which can be condoned/ curtailed at the discretion of the Competent Authority.
17. The project staff shall have to make arrangements for accommodation during their tenure in the project. However, HRA shall be admissible as per applicable rules.
18. The offer letter shall be issued to the candidate initially for a period for which funds are available.
19. A review committee will assess the performance of the project staff and recommend for their extension, if required, subject to the availability of funds in the project.
20. CSIR guidelines for the Ethics in Research and in Governance, as made applicable vide CSIR OM No. 30/GB/2019-MD dated February 28, 2020, and amended from time to time shall apply.
21. No TA will be paid to the candidates for appearing in the interview in case of offline interviews.
22. Other terms & conditions will be governed as per guidelines issued by the funding agency/ CSIR-NEERI for the engagement of the Project Staff as amended from time to time.
23. The relaxation in the age limit for the candidates belonging to the category of SC/ST/PwBD/Women and another category of OBC shall be 05 years and 03 years respectively as per Govt. of India instructions issued in this regard from time to time.
24. House rent allowance or HRA payable shall be as per the extant Government of India rules as applicable to CSIR employees.
25. In the case of Project Associates (PAT-I & PAT-II), if a selected candidate qualifies for the CSIR UGC/NET examination after his / her appointment, he/she can be considered for the payment of higher emoluments subject to the availability of provision for the same and availability of funds in the Project along with the specific recommendation of PI which are duly endorsed by BDPM -5B (Head PME) and Finance and after the approval of Director /DG, CSIR (as the case may be)
