- 1. Candidate should not be more than 37 years of age as on the last date of submission of application.
- 2. Candidates should have passed subject of Punjabi upto Matric standard.
- Candidate must fulfill eligibility criteria for the post he/she is applying for as
  on date of Interview of above post. The applicant must read carefully all the
  guidelines and instructions mentioned on the website before appearing for
  interview.
- 4. Candidates must ensure to bring their original testimonials related to Qualification, Experience, Punjabi upto Matriculation, Age proof etc. and one self attested photocopy of all such documents for submission.
- 5. Candidates must bring 2 latest passport size photographs at the time of Interview.
- 6. In case, any certificate/testimonial of an applicant is found fake at any stage of recruitment or issued by an incompetent authority, eligibility/appointment of that applicant would be cancelled with immediate effect and a legal action may be taken against him/her. If any candidate is found not to be fulfilling the eligibility/selection criteria at the time of interview or at any point of time in the entire recruitment process by the screening or selection committee, his/her candidature will be cancelled/ rejected for the said post.

- 7. Appearing for Interview does not imply that candidate has fulfilled all the criteria given in the advertisement and he/she is eligible for the post. Eligibility of the candidate will be determined after thorough scrutiny of the application filled by the candidate.
- 8. The appointment will only be on contract basis on a consolidated remuneration for a period of one year which may be renewed depending on the requirement & performance of the candidate.
