4. Norms for appearing the Walk-in-Interview:

- A. Interested candidates are requested to appear before the Interview Board along with his/her Bio-data as per the prescribed format (Format Enclosed) and with all original documents.
- B. Self-attested photocopy of the following documents needs to be submitted: (a) Copies of qualification (all Mark sheet) from Madhyamik onwards, (b) Valid Registration Certificate from Dental Council of India/ State Council,(c) Caste Certificate (for reserved categories), (d) Permanent Resident Certificate of Tripura (PRTC), (e) Age Proof (Madhyamik Admit Card)/ 10th Standard Board Admit Card), (f) Photo ID with address (Aadhar card/ Driving license/ Voter ID).

5. Age relaxation limit:

40 years for UR candidates & 45 years for SC/ST candidates for all categories of post.

2. Candidates' selection criteria:

The candidates will be selected based on their merit on the basis with 50% weight age on Academic Performance Indicator (API) and rest 50% for interview/ viva-voce/ performance before the Interview Board by the candidate.

3. Instructions:

- 1. Vacancies shall be subject to the State Reservation Policy of Tripura. Horizontal reservation for women in the posts shall be applicable as per the policy notified by the State Government. Only those candidates having the Permanent Resident Certificate of Tripura (PRTC), issued by the Govt. of Tripura shall be eligible.
- 2. In the case of CGPA/ GPA, applicants shall provide marks details in percentage at the time of filling the online form and documentary proof for the basis of calculation of percentage shall be produced whenever it is required. If the applicant fails to present the above, supporting documents he/she shall be liable for the disqualification/cancellation of his/her candidature.
- 3. T.A. & D.A. will not be admissible for appearing in the recruitment procedure.
- 4. The selected candidates will have to perform their duties for a minimum of 06 to 08 hours in a day.
- 5. Name of the short listed candidate will be published in the official website of NHM (http://tripuranrhm.gov.in/)in due course of time.
- 6. If at any stage of recruitment, it is found that the candidate does not fulfil the eligibility criteria and/or that she/ he has furnished incorrect/ false information/ certificate/ documents or has suppressed any material fact(s), his/her candidature shall stand cancelled, apart from taking actions as per legal provisions.
- 7. The decision of the competent authority of the State Health & Family Welfare Society, Tripura in any matter relating to the recruitment at any stage of the recruitment process will be final and binding upon the candidate.
- 8. Any candidate against whom a criminal case is pending in any court or has been convicted by any court, such candidates are barred from applying in the above posts.
- 9. The Mission Director, National Health Mission, Tripura shall have the right to suspend/ cancel any application/ entire recruitment process or a part thereof without showing any reason.

10. The Mission Director, National Fleatth Mission, Tripura reserves the right to amend recruitment rules and process at any time of the selection. Any such amendment shall be valid and binding on the candidates during the recruitment process.

- 11. Any legal dispute pertaining to the recruitment process shall be under the jurisdiction of the courts in Agartala, Tripura.
- 12. Further correspondence in this regard will be notified in the official website of NHM (http://tripuranrhm.gov.in) in due course of time.
- 13. Candidates already employed in any Govt./ Semi-Govt./Societies/ any other organization shall have to submit No Objection Certificate from their employer while applying for the post and have to produce release order from their concerned employers while joining in the above mentioned post, failing which his/her candidature will be cancelled and the next eligible will be selected for filling up the vacant post.
