The candidates are required to download their Admit Cards from CSIR-CEERI website i.e. <https://www.ceeri.res.in/> entering the required credentials (i.e. Application number, Date of Birth, Mobile OTP etc.). Candidates are advised to read the instructions contained in the Admit Card carefully before appearing in the trade test. Admit Cards for Trade Test can be downloaded from 25.11.2025 onwards from CEERI website.

3. In case any candidate faces difficulty in downloading the admit card, he/she can contact through the registered email ID to recruitment.ceeri@csir.res.in well in advance.

4. The eligibility of candidates notified vide OM of even number dated 19.11.2025 to appear in the Trade Test is purely provisional and subject to verification of their documents, certificates, and compliance with all eligibility conditions prescribed in the official notifications. If any discrepancy is detected at any stage, the candidature is liable to be cancelled without prior notice. Candidates are, therefore, advised to ensure that they meet all eligibility requirements as per the advertisements and criteria issued by this Institute from time to time.

5. Those who will qualify in the trade test will be called for written test and admit cards thereof will be issued separately.

6. Candidates shall arrange their own accommodation/ travel to appear in the Trade Test. CSIR-CEERI will not bear any TA/DA, accommodation charges or other expenses for candidates appearing in Trade Test.

7. Candidates indulging in any form of misconduct or unfair means or bringing in any influence, political or otherwise, shall be treated as a disqualification and may face further legal/administrative action.
