Other Terms & Conditions:

1. As per Government of India reservation norms the reservation for the advertised Posts are as follows: UR – 06, OBC – 02, SC – 01 and EWS – 01.
2. The engagement is purely on temporary basis for a period of 11 months (They may or may not be extended further). In case of extension, it can be given based on performance evaluation and recommendation of HoDs / Deans of respective Schools.
3. The consolidated monthly salary will be Rs.70,000/- per month. No other emoluments / allowances / medical reimbursement are applicable. No vacation salary is payable. No compensatory leaves are applicable.
4. Candidates must write their Email ID neatly and correctly for mailing written examination/Interview/appointment letter as attachment. The email date will be considered as the official date of dispatch and receipt of communication. Candidate not having an email-ID must create an ID and check it regularly for further communication.
5. The university shall verify the antecedents or documents submitted at any time at the time of engagement or during the tenure of service. In case, it is detected that the documents submitted are fake or the candidate has clandestine antecedents / background and has suppressed the said information, his/her services shall be terminated forth with.

6. Candidates, who have obtained degrees or diplomas or certificates for various courses from any Institution declared fake/derecognized by the University Grants Commission, New Delhi shall not be eligible for being considered for recruitment to the posts advertised.
7. No person shall be recruited unless he/she is in good mental and bodily health and free from any physical defect that is likely to interfere with the efficient performance of his official duties. Before a candidate recruited directly is finally approved for appointment to the establishment he shall be required to produce a medical certificate of physical fitness from whom the appointing authority specifies.
8. Candidates offered the position will have to join within one week and should produce the original marksheets/certificates and testimonials along with address proof at the time of joining.
9. Errors and omissions in notification and selection process are subject to corrections.
10. The University has no compulsion to issue an experience certificate having worked as contract faculty.
11. The University reserves the right to withdraw any advertised post (s) at any time without giving any reason or change or alter the number of vacancies against any of the posts advertised or not to fill any vacancy.
12. At the time of Interview, candidates have to produce the original certificates/ testimonials/ books/ published research papers/ etc.
13. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
14. No interim correspondence shall be entertained.
15. Candidates appointed shall not be entitled to claim for any weightage for regular appointment /position in the University at a later date.
16. Selected candidates must submit a copy of PAN Card at the time of joining/ within a period of one month to release the payment.
17. Anything not covered above shall be governed by UGC/MoE/GOI norms issued from time to time.
18. Selected contractual faculty would be given workload as per UGC norms and must work full time from the campus during the tenure of engagement and should have their online teaching arrangements like own laptop etc.
19. Selected Contractual Faculty will also liable for undertaking any other task/duties/job/assignments as deemed fit by the authority of the institute from time to time.
20. Legal disputes if any will be subject to High Court of M.P. jurisdiction only.
