- The minimum qualification for admission to M.Sc. in Data Science programme is B.Sc. in the relevant discipline.
- The candidates should have passed and secured at least 6.5 CGPA (on a 10-point scale) or 60% for GEN/GEN-EWS/OBC, whereas 6.0 CGPA (on a 10-point scale) or 55% in case of SC/ST/PwD candidates. The abovementioned CGPA/Percentage should be awarded by a recognized University/Institute. The above-mentioned CGPA/Percentage should be awarded by a recognized University/Institute.
