General information for engagement of Young Professional of Organic Chemistry at National Sugar Institute, Kanpur.

1. Young Professional may apply in the prescribed preformed to work, at National Sugar Institute Kanpur

Terms and conditions of contract are as given under-

i. Eligibility Qualification & Experience:

- (i) Post Graduate degree in Chemistry preferably specialized in organic chemistry from any recognized university/institute.
- (ii) With five years' research experience in Organic chemistry

ii. Tenure: Young Professional will be engaged for a fixed period of one year but not exceeding 3 years for providing high quality services on specific projects as per requirement of the concerned division.

iii. Remuneration: A consolidated amount of Rs. 40,000/- per month shall be paid.

In case, the contract is for more than one year, the remuneration shall be reviewed after completion of one year, Total enhancement of remuneration shall not exceed 5% annually in any case. The enhancement in remuneration will be based on his/her performance during the year after recommendation of NSI, Kanpur which shall be subject to concurrence of IFD of Department of Food & Public Distribution.

iv. Allowances: No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities such as DA, accommodation, residential phone/conveyance/transport, foreign travel, personal staff, medical reimbursement, CGHS etc. would be admissible to the Young Professionals.

v. Leave: Young Professional shall be eligible for 8 days casual leave for a completed period of 1 year on pro-rata basis. No remuneration for the period of absence in excess of the admissible leave will be paid to Young Professional. Un-availed leave shall neither be carried forward to next year nor encashed

vii. Tax deduction at source (TDS): TDS as applicable under the rules shall be deducted from the monthly remuneration. A TDS certificate shall be issued by the concerned DDO on demand.

vii. Termination of Engagement: The services of the Young Professional can be laid off after giving one month's notice. However, the department reserves the rights to terminate the contract at any time without prior notice and without providing any reason for it. The individual Young Professional can also seek for termination of the contract upon giving one month's notice to the Department

viii. Age limit: Age should not exceed 35 years.

x. Legal Status and settlement of Disputes

The individual Young Professional shall have the legal status of an independent Young Professional Department of Food & Public Distribution and shall not be regarded for any purposes, as being either a "staff member" of the Department or an "official" of the Department. Accordingly, nothing within or relating to the contract shall establish the relationship of employer and employee.

The Department and the individual Young Professional shall use their best efforts to amicably settle any dispute, controversy or claim arising out of the contract or the breach, termination or invalidity thereof.

x. Confidentiality of Data and Documents

- (i) The intellectual Property Rights (IPR) of the data collected as well as deliverables produced during the consultancy period for the Ministry/Organization shall remain with the Department/Organization.
- (ii) No one shall utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of his assignment or during the course of assignment for the Department/organization, without the express written consent of the Department/Organization.
- (iii) The Young Professional shall be bound to hand over the entire set of records of assignment to the Department before the expiry of the contract, and before the final payment is released by the Department/Organization.
