Walk-In Interview for Apprenticeship Positions on 06th July 2026

CSIR-National Institute of Oceanography, Goa is a premier institute functioning under the aegis of Council of Scientific and Industrial Research (CSIR), an autonomous body functioning under the Department of Scientific and Industrial Research, Ministry of Science and Technology, Government of India.

Walk-in-interviews are scheduled to be held at **CSIR - NIO, Head Quarters Goa** for the selection of **Technician (Diploma)/Graduate (Non-Engineering Degree)** holders for the engagement as Apprentice Trainees under the Apprenticeship Act, 1961. The details of the positions are given below.

Note: Candidates appearing for Walk-in-interview for apprenticeship training, in trades other than mentioned above, will not be entertained.

III. MINIMUM EDUCATIONAL QUALIFICATIONS:

A. Technician (Diploma)/ Graduate (Degree) Apprentices:

- Three Years Full-time Diploma in Engineering/Technology granted by a State Council or Board of Technical Education Established by a State Government/University/Institutions in relevant discipline.
- Full Time Graduate degree (Non-Engineering) granted by a recognized University/Institutions in relevant discipline.

IV. OTHER ELIGIBILITY REQUIREMENTS:

1. Graduate/Technician candidates who have passed the qualifying exam in **2022/2023/2024/2025/2026 are only eligible.**
2. Candidates who have registered themselves in the Apprenticeship Portal for Apprenticeship and who fulfil the eligibility criteria as indicated above will be considered for appearing in the walk-in-interview.
3. **Candidates should not have undergone or presently undergoing Apprenticeship Training in CSIR or elsewhere.**
4. **Candidates should not have experience of one year or more in any job.**
5. Sandwich diplomas, private diploma, part time/Distance/short term/certificate courses etc., are not acceptable.

V. AGE LIMIT:

Technician/ Diploma: Minimum 18 years and maximum 24 years for Technician/Diploma Apprentices as on date of interview.

Graduate/Degree: Minimum 21 years and maximum 26 years for Graduate/Degree Apprentices as on date of interview.

Relaxation: Relaxation in upper age limit as per GOI guidelines by 5 years for SC/ST, 3 years for OBC (NCL) subject to the production of a relevant certificate in the prescribed format of GOI signed by the competent authority. Candidates belonging to PWD category shall be given age relaxation upto 10 years (upto 15 years for SC/ST and upto 13 years for OBC (Non-Creamy Layer) Candidates.

Ex-Servicemen: Upper age limit is relaxable as per the extant rules as applicable from time to time.

VI. RESERVATION OF VACANCIES:

Guidelines under Apprentices Act on reservation for SC/ST/OBC (NCL)/PwBD/EWS will be followed. Those who are claiming reservation under SC/ST/OBC (NCL)/PwBD/EWS shall produce certificate issued by appropriate authority in the format prescribed by Govt. of India, failing which they will be considered as 'General' category candidates only, if otherwise eligible.

VII. APPRENTICESHIP REGISTRATION:

Candidates are advised to register as Graduate (Degree)/ Technician (Diploma) Apprentices online in the following portal under the respective state as per their trades in

- Candidates should ensure that they submit all the documents mentioned above. In the event of failure to submit any of the required documents as mentioned above at the time of walk-in-interview, their candidature will not be considered.

1. Date & Time of Walk-in-Interview: (**Reporting Time: 08.30 AM to 10.00 AM**). The candidate reporting after **10.00 AM** will not be entertained. No TA/DA will be provided for attending the interview. The interview will start from 10.15 AM onwards for the candidates who reported before 10.00 AM.
2. Candidates have to submit their duly filled-in application form given at the end of this advertisement along with original certificates for verification and self-attested copies of education qualification certificates, relevant mark sheets, proof of date of birth (copy of SSLC/HSC/Birth certificate/any other proof), Aadhaar Card, community/category certificate (if applicable), a passport-size photograph at the time of interview.
3. Candidates should have their valid Aadhaar Number and NATS enrollment number.
4. The original documents including educational qualification, Birth/SSLC certificate, community and other certificates in respect of selected candidate will be verified at the time of walk-in- interview. Your joining at CSIR-NIO as apprenticeship trainee is subject to verification of certificates.
5. If number of candidates are more, the Selection Committee shall adopt its own criteria and conduct a written examination and shortlist the candidates for personal interview in proportionate to the available vacancies.
6. **Hostel Accommodation will not be provided for the trainees. Selected candidates will have to make their own arrangements for stay after joining for the training.**
7. On successful completion of training, the apprenticeship trainees will be awarded National Apprenticeship Certificate by the National Council for Vocational Training (NCVT)/ BOAT.

9. Candidates are advised to periodically visit our website as all future correspondence and latest information with regard to final screening/selection result shall be posted in our website (<https://www.nio.res.in>)
