No paper Summon Letters will be issued for the Personality Test/Viva-voce by the Commission. The date and time of Personality Test/Viva-voce will not be intimated to the qualified candidates individually.

No request for change in the date and time of the Personality Test/Viva-voce intimated to the candidates will be entertained.

At the time of filling up of the Application Forms, all the particulars were not obtained from the candidates. Accordingly, all the candidates, who have qualified for Personality Test/Viva-voce, are requested to fill up the Detailed Application Form (DAF), forming **Annexure-B** to this notification, which shall be uploaded separately, and submit the same at J&K Public Service Commission office at Jammu/ Camp Office Srinagar by or before **28.02.2019**, in person, to the Deputy/ Assistant Controller of the Examinations who are hereby designated as the Nodal Officers for the purpose.

No request for any type of change/modification of information already supplied in DAF would be entertained by the Commission.

The marks sheets of all the candidates who appeared in the Written Examination will be put on the Commission's Website i.e. www.jkpsc.nic.in within one month from the date of publication of the final result and will remain available on the Website for a period of 30 days.
