It is for information of all concerned that, on the basis of the Main written examination held from 03.11.2020 to 06.11.2020 for recruitment to the posts of Civil Judges in Odisha Judicial Service, 2019, pursuant to the Advt. No. **12 of 2019-20, 129 (One hundred twenty nine)** candidates, bearing following Roll Numbers have been qualified for admission to the viva voce test. The physical verification of original certificates, documents etc. in respect of above qualified candidates will be held in the office of the Commission at 19, Dr. P. K. Parija Road, Cuttack – 753001 **from 08.02.2021 to 11.02.2021** as per the programme detailed below.

The candidates are required to come with hard-copies of online application forms (indicating their Roll Nos. at the top right corner), three passport size photographs, self-attested copies of all relevant certificates, documents etc. **with original of the same** as per **Para - 8** of the Advertisement and duly filled in **“Attestation Form” & “Bio-data Form”** (to be downloaded from the website of the Commission.) and submit the same **in person** on the day of verification.

It is also made clear that the candidature of these candidates for the recruitment is **purely provisional**. The candidature is liable to rejection in the event of inadequacy /deficiency found at any stage before or after the verification of original certificate /documents and is subject to fulfillment of terms and conditions laid down in the advertisement.

The Viva Voce Test in respect of eligible candidates will be held **from 22.02.2021 onwards**. The detailed programme of Viva Voce Test will be published later on after completion of verification process *in the website of the Commission.*
