3. Matriculation Certificate in support of declaration of age.
4. Intermediate/ +2 Examination Certificate.
5. B. F. Sc. Degree Certificate issued from recognized University.
6. Mark Sheets in support of all the Examinations (H.S.C, +2 & B.F.Sc.) including fail marks, if any, issued by the concerned Board/Council/University.
7. Fishery Registration Certificate.
8. Required Odia Test Pass Certificate from the competent authority
9. Caste Certificate by birth in support of claim as SEBC/ST/SC whichever applicable. (which has been uploaded with online Application Form)
10. Permanent Disability Certificate (indicating percentage of permanent disability i.e. 40% and more)
11. Ex-Servicemen claiming reservation are required to submit/upload Release Certificate issued as per Orissa Ex-Servicemen (recruitment to State Civil Services and Posts) Rules, 1985 vide G.A. Deptt. Notification No. 22586-Gen., dt.16.10.1985. Further, Ex-Servicemen candidates must submit an affidavit undertaking that he/she has not been appointed against any civil post after retirement from military service.

14. Attestation form duly filled in by the candidate and signed by the Gazetted Officer (downloaded from the website of the OPSC)
15. Candidate Information Form (CIF)/ Bio-data form duly filled in affixed with passport size photograph (downloaded from the website of the OPSC)
