It is for information of all concerned that on the basis of written examination held on 26.08.2023 & 27.08.2023 for Special Drive recruitment for SC & ST candidates to the posts of **Public Prosecutor (Group-A)**, pursuant to **Advt. The candidature is liable to rejection in the event of inadequacy/ deficiency found at any stage before or after the verification of original certificate/documents and is subject to fulfillment of terms and conditions laid down in the advertisement.

**Mere participation in the document verification does not reserve any right to appear the Viva Voce test.** The candidates shall be allowed to the Viva Voce test on scheduled date and time mentioned below subject to fulfillment of their eligibility in all respect as per verification of original certificate/ documents.
