Applications are invited for the following post PURELY ON TEMPORARY BASIS under the ICMR-sanctioned Centre for Advanced Research (CAR) 'Establishing Center for Advanced Research for Hematopoietic Stem Cell Transplantation in Children at PGIMER, Chandigarh. [ICMR Project ID: 2022-17685] under the sub-projects titled "Development of a training program in hematology and hematopoietic stem cell transplantation as a stepping stone to providing cost-effective treatment near home to patients in the future: A collaboration between PGIMER, Chandigarh, and regional medical colleges" and "Feasibility and outcomes of upfront haploidentical hematopoietic stem cell transplant from related donors in children with high-risk aplastic anemia who lack a matched sibling donor."

<b>Age limit</b>	Not exceeding 30 years (Relaxable up to 3 years for OBC & 5 years for SC/ST candidates)
<b>Expected Salary</b>	INR. 18,000/- + HRA (as per rules)
<b>Contract period</b>	For one year which may be extended further as per requirement/extension of the project.


1. All the educational qualifications/certificates shall be from the recognized Board/University.
2. All the experience gained shall be preferably from the Govt. Organizations and shall be counted after the date of completion of minimum essential qualifications. Experience from reputed National/International Organizations shall also be considered.
3. All caste certificates shall be issued by the authorized offices of the Govt. as per the required format.
4. The cut-off date for the age limit will be as on the last date for submitting applications. The rules of the upper age limit are relaxable as per ICMR rules.
5. All positions are meant for temporary extramural project for appointment purely on a temporary contract basis and co-terminus with the project.
6. Duration of project: 5 years
7. The job requirement indicative is only suggestive. There will be additional work and responsibilities as demanded by the clinical patient care and the project and as required by



- the investigator(s).

  10. The Project Investigator and/or appointing authority reserves the right to terminate the service of project personnel even during the agreed contract period or extended contract period without assigning any reason.

**Duration of Engagement:** The contract for the engagement of project staff shall be up to one year, which shall be extendable up to 3 to 5 years, subject to requirements and performance review. The fixed-term engagement(s), i.e., initial as well as extended, shall automatically cease/conclude if the same is not extended within the tenure.
