However, the candidates whose result will be declared after 30th June 2019 or who will fail to produce valid pass certificate of their degree as on 30th June 2019 are 'NOT ELIGIBLE' for this exam.

Upper Age Limit:- Age limit for all posts is 37 years (relaxable by 5 years for SC/ST candidates and 3 years for OBC candidates). The age relaxation for Persons with Disabilities would be ten years (additional 5 years for SC/ST and 3 years for OBC). The candidates who have completed three years tenure of Senior Residency or have done DM/M.Ch are not eligible for the post of Senior Resident.

Abbreviations:- UR = Un-reserved, SC = Scheduled Caste, ST = Scheduled Tribe, OBC = Other Backward Classes, EWS = Economically Weaker Section. PWD = Persons with Disabilities, O.A. = one arm affected (R or L); O.L. = one leg affected (R or L), HH = Hearing Handicapped (persons suffering from hearing impairment).

NOTE:- I. Age and all other qualifications will be counted as on last date of receipt of application i.e. 27.05.2019. Overage candidates need not apply.

II. The vacancies which will fall vacant in different specialities till 30th June 2019, if any, due to resignation, termination, leaving the Institute midway etc. will also be filled on regular basis on the basis of this examination from the candidates in waiting list.

III. The above vacancies are provisional and subject to variation. The Director, PGIMER, Chandigarh reserves the right to vary the vacancies including reserved vacancies.

IV. Candidates should ensure that they fulfill the eligibility criteria for the Senior Residents & Junior/Senior Demonstrators in different specialities and Senior Medical Officer (Casualty in Emergency). Candidates are required to apply through the Institute' website www.pgimer.edu.in. For complete process, candidate should see and follow the instructions of Part E (How to Apply) of this advertisement. The candidates should regularly check the website as the Roll Number & other information will be conveyed through the Institutional website only. Candidate should mention his/her working Registered Mobile Number (RMN) in the column provided as intimation about the exam will also be sent through SMS on the Registered Mobile Number (RMN).

V. FOR PERSONS WITH DISABILITY CATEGORY:

Eight (8) posts from amongst the posts of Senior Residents and Senior Medical Officers (Casualty in Emergency) in the Departments of Anaesthesia, Anatomy, Biochemistry, Community Medicine, Dermatology, Forensic Medicine, Hospital Administration, Internal Medicine, Medical Microbiology, Nuclear Medicine, Pathology, Pediatrics, Pharmacology, Physical & Rehabilitation Medicine, Radio-diagnosis, Radiotherapy, Transfusion Medicine are meant for Persons with Disabilities category (OA-OL) in non-surgical departments and for Oral Health Science Centre (Sr.No.14) for OL, HH categories.

A total of Eight (8) posts under different categories are reserved under 4% quota of Persons With Disability category and the candidates will be adjusted against the vacancy of respective categories of SC/ST/OBC/EWS/Unreserved, as the case may be.

The persons who suffer from not less than 40% of disability will only be eligible for the benefit of reservation and other relaxations as permissible under the rules. The applicant must have a valid Disability Certificate issued by the competent authority i.e. Medical Board duly constituted by

the Central or the State Government. Certificate issued by the Medical Practitioner, Hospital or any other Institution will not be considered. The physical disability of finally selected candidates would be ascertained by a Medical Board of the Institute specifically constituted for this purpose.

Relaxation for providing facilities of Scribe / Reader / Lab Assistant and extra time would be allowed to persons having disability of 40% or more, if so desired by the persons as per instructions/guidelines issued vide OM No.34-02/2015-DD.III dated 29.8.2018 modified vide corrigendum F.No.34-02/2015-DD.III(pt) dated 8.2.2019 by the Government of India.

The candidates applying under the category 'Persons With Disabilities' for the above said posts are exempted for payment of any application fee.

VI. FOR ECONOMICALLY WEAKER SECTION:

- (i) EWS (Economically Weaker Section) vacancies are tentative and subject to further direction/clarification of GOI and are subject to outcome of any litigation pending in the court of law. The Income and Asset Certificate (**Annexure-A**) as required has to be issued by any one of the authorities mentioned in the prescribed format shall only be accepted as proof of candidate's claim as belonging to EWS. For detailed guidelines/eligibility regarding reservation for EWS in direct recruitment, candidate may refer to the O.M. No.36039/1/2019-Estt(Res) of Government of India, Ministry of Personnel, Public Grievances & Pensions dated 31.1.2019.
- (ii) Candidates seeking reservation/relaxation benefits under SC/ST/OBC/EWS/PWD must ensure that they are entitled to such reservation/relaxation as per eligibility prescribed in the rules/notice. They should also be in possession of all the requisite certificates in the prescribed format as on date in support of their claim as stipulated in the rules/notice for such benefits and these certificates should be dated earlier than the due date (closing date of receipt of application for this exam).

B. ELIGIBILITY CRITERIA:-

ESSENTIAL QUALIFICATIONS FOR ALL POSTS OF SENIOR RESIDENTS:-

- a) A Medical qualification included in the first or second schedule or Part-II of the third schedule to the Indian Medical Council Act, 1956 (person possessing qualifications included in the Part-II of the third schedule should also fulfill the conditions specified in Section 13 (3) of the Act).
- b) Must be registered with the Central/State Medical Council.

- c) A Postgraduate degree i.e. MD/MS in the specialty concerned or its equivalent except for the following posts for which required postgraduate degree will be as under or its equivalent:-

Forensic Medicine	:	M.D. (Forensic Medicine) OR M.D. (Pathology) OR MD/MS (Anatomy) OR M.S. (General Surgery)
Hospital Administration	:	M.D./M.S. OR a recognized Qualification equivalent thereto, in any medical discipline OR Master Degree in Hospital Administration from a recognized Institute/University or a recognized qualification equivalent thereto.
Nuclear Medicine	:	M.D./D.N.B. (Nuclear Medicine)
Renal Transplant Surgery	:	M.S. (General Surgery)
Transfusion Medicine	:	M.D. (Transfusion Medicine) OR M.D. (Pathology)
Physical Medicine & Rehabilitation Medicine	:	A postgraduate degree i.e. M.D. (PRM / MD (Sports Medicine as a qualifying degree) in the subject of speciality concerned of an Indian University or qualifications recognized equivalent thereto.

FOR DENTISTRY (OHSC):-

- A recognized Dental qualification included in the Part-I or Part-III of the schedule to the Dentistry Act, 1948 (person possessing qualifications included in Part-I or specified in the sub-section (1) and (2) or (4) of Section 10 of the Dentist Act, 1948).
- Must be registered with Dental Council of India.
- A Postgraduate qualification viz. MDS in the speciality concerned.

FOR SENIOR MEDICAL OFFICER (Casualty in Emergency):-

- and b) same for the post of Senior Resident.
- Postgraduate qualification is MD/MS (Medicine/Surgery).

ESSENTIAL QUALIFICATION

FOR SENIOR DEMONSTRATOR (Non-Medical):-

- M.Sc. in subject concerned.
- Ph.D. in the subject concerned/allied subject.

FOR JUNIOR DEMONSTRATOR: M.Sc. in the subject concerned.

FOR SCHOOL OF PUBLIC HEALTH (Community Medicine):

Junior Demonstrator : M.A./M.Sc. in Nutrition or Applied Nutrition/MPH. (Nutrition)

C. METHOD OF SELECTION:-

Final selection to the tenure posts of Senior Resident/Jr./Sr. Demonstrator/Senior Medical Officer will be done on the basis of aggregate score obtained by the candidate in the written examination of 75 marks and departmental interview & assessment for 25 marks. The minimum qualifying/eligibility criteria for both written examination and departmental interview & assessment separately will be 40% marks for General category and 35% for SC/ST/OBC categories respectively.

There will be an objective type written examination which will consist of fifty (50) questions of one and half marks (1½) each (total 75 marks). There will be negative marking to the extent of 0.25 marks for each wrong answer in the objective type paper. The candidate will be shortlisted on the basis of written examination in the ratio of 1:3 i.e. for each advertised post, there will be three candidates called for departmental interview & assessment. The result of written examination will be declared on next day. The departmental interview & assessment would consist of 25 marks and will be based on clinical evaluation/laboratory testing / detailed structured viva / personal interview as the case may be. The date and time of written examination, document verification before the Committee and departmental interview & assessment would be as under:-

Candidates are to ensure their personal presence for the written examination, document verification and departmental interview & assessment (alongwith all the original documents) before the specified committee/department etc.

D. RESOLUTION OF TIE CASES:-

In cases, where more than one candidate scores equal aggregate marks, the tie will be resolved by the following method:-

- (i) First by using number of wrong answers / negative marks in the objective type written examination wherein the candidate(s) with less wrong answers / negative marks will be placed higher.
- (ii) If not resolved by (i) above, the aggregate percentage of marks obtained in 10+2 examination wherein a candidate with higher aggregate percentage (%) of marks will be placed higher in merit.

- (iii) If not resolved by (i) & (ii) above, the aggregate percentage of marks obtained in Matric standard, the candidate having higher aggregate percentage of marks (%) will be placed higher in merit.

E. HOW TO APPLY:-

1. The candidate applying for the post should first confirm their eligibility before going to the website of www.pgimer.edu.in.
2. The candidate will first fill (i) Advt. No. (ii) Post Code Number, (iii) category and (iv) date of birth on the website and then take a printout of the application form and challan. The application form is to be filled in by BLUE/BLACK BALL PEN in BLOCK LETTERS.
3. The candidate should fill his/her application form available on the PGIMER website. He/she should fill all the column of the form. No column should be left blank. Candidate should fill and disclose his/her complete educational qualification (10th onwards), category, employment, if already working with the Govt. etc. as required in the application form. If at a later stage, it is found that applicant has not disclosed and filled the complete application form or has filled wrong information or suppressed any information, his/her candidature will be cancelled and appointment, if already issued, will be withdrawn/terminated. After filling application form, the candidate should deposit the application fee through challan form (triplicate) in any branch of State Bank of India.
4. **Candidates can go to any Branch of State Bank of India with the fee Payment Challan duly filled in and pay the prescribed Application Fee in the "Power Jyoti" PUL current account of PGIMER. The account No. of PGIMER for recruitment is 35700657347. The candidates after having deposited the fee in the bank must ensure that they have Triplicate Fee Payment Challan with Journal No./Challan No. given by the bank on it. They should mention this Journal/Challan number on the space provided in the application form and keep this challan form with them for future use.**

6. Candidates should ensure that the details to be filled in by the State Bank of India officials are filled in complete in all three copies of the challan form along with the seal, challan no. and signature of the Bank Official of the Branch.
7. Candidates must note that no other form of payment of application fees like Demand Draft, Banker's Cheque, Money Order, Postal order, etc. will be accepted under any circumstances. The PGIMER will not be responsible for any remittance made in any form other than the method prescribed above and such applications without requisite application fee submitted through any other mode except prescribed in column 4 above, are likely to be rejected.

8. The candidates should ensure that they submit the application immediately after payment of fees, since the same is non-refundable. No representation/request/demand for refund of application fees will be entertained, if the candidate fails to apply within the stipulated time after payment of application fee.
9. Candidates are required to have a valid personal e-mail ID which should be kept active during the recruitment process. The candidates should ensure that the e-mail ID is not shared or mentioned to any other person. It is requested not to use any other person's e-mail ID. In case, a candidate does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID before applying OFFLINE.
10. The candidate is required to mention clearly his/her Email ID in the specified column of application form.
11. The eligible candidates will be informed with regard to their Roll Number and examination centre etc. on PGI website. This facility would be available on this **website THREE DAYS before the actual date of written examination.**
12. **The application complete in all respects alongwith copies of certificates duly self attested or by the Gazetted Officer in support of educational qualification(s), experience, age/date of birth certificate, caste certificate, latest OBC certificate, NOC from the present employer, if employed, one latest passport size photograph and one copy of challan form should be sent through registered post or Speed Post or personally only to the Administrative Officer, Recruitment Cell, PGIMER, Sector-12, Chandigarh – 160012. No application received after due date will be accepted. The Institute would not be responsible for postal delay or delay due to any other reason and late received application, if any, will be outrightly rejected. No correspondence will be entertained in this regard.**
13. **The candidates working in the Govt./Semi Govt./Corporate Body/Undertaking of the Central Govt./State Govt. should send their duly filled in application form through proper channel. However, in order to avoid delay, they may send an advance copy of the duly filled in application form directly. They will be issued roll number for the written examination only after receipt of their application through proper channel.**
14. Decision of the PGIMER, Chandigarh in all matters regarding selection would be final and binding on all candidates. No correspondence whatsoever would be entertained by the PGIMER, Chandigarh in this regard.

F. SELECTION PROCEDURE:-

1. The short-listed candidates (after the written examination) will be called for Document Verification and Departmental Interview & Assessment. However, qualifying the written examination would be provisional subject to fulfillment of all requirements.
2. The selected candidates will be issued appointment letters. The appointment of selected candidates is subject to his/her being declared medically fit by the PGIMER, Chandigarh.

G. GENERAL INSTRUCTIONS:-

- Candidates are advised in their own interest to apply much before the closing date and should not wait till the last date.
- A candidate applying for more than one post, is required to submit separate application, complete in all respects.
- Original application must be accompanied with copies of certificates i.e. qualification, experience, character, caste (if belong to SC/ST/OBC/EWS) duly self attested and **NOC from the employer, if employed.**
- The candidate appearing in MD/MS examination during June 2019 can also apply for the post of Senior Residents. However, their candidature will be considered only, if they supply their MD/MS examination pass certificate from the concerned recognized Institution/University at the time of document verification.
- The post of the Senior Residents, Junior/Senior Demonstrators and Senior Medical Officer are for three years tenure to be renewed every year subject to satisfactory work and conduct.
- The eligible candidates are required to bring all the original certificates/testimonials in support of their qualification, experience, date of birth, caste certificate etc. and also **NO OBJECTION CERTIFICATE** from the present employer, if working in the Govt./Semi Govt./Corporate Body/Undertaking of the Central/State Govt. at the time of document verification.
- Candidate is required to disclose his/her details clearly suppressing of any material will be treated seriously and candidate will be disqualified/terminated, if found so.
- No T.A. will be paid for attending the written examination/departmental interview & assessment.
- **The candidates are required to submit two extra Photostat copy of application form (duly filled) alongwith original application.**
- Incomplete application in any respect and received after the due date will not be entertained (PGI will not be responsible for any postal delay) or delay due to any other reasons.
- No separate letter for written test, document verification and departmental interview & assessment will be sent.
- The candidates must ensure that they fulfill eligibility criteria and that the particulars furnished by them in the applications are correct in all respects. If at any stage it is found that the candidate has furnished any incorrect information or has suppressed material fact(s), his/her candidature will stand cancelled. If any of these shortcoming(s) is/are detected even after the appointment, his/her services will be summarily terminated.
- In case, the last date of receipt of applications is declared holiday, the last date for receipt of the applications will be considered as next working day.
- The number of posts can be increased/decreased at any time by the orders of the competent authority. These posts include backlog vacancies also. Physically handicapped persons may also apply, their cases will be considered as per Govt. of India's instructions in this regard.
