Punjab State e-Governance Society (PSeGS) under the aegis of Department of Good Governance & Information Technology, Punjab is executing a number of core infrastructure projects and other large scale transformational projects, pertaining to implementation of information technology and e-Governance. Applications are invited from the eligible candidates for filling the following position purely on contract basis initially for a period of 2 years which may be extended on a year to year basis, depending upon the performance of the appointee and the requirement of PSeGS:

2. Eligibility and Educational qualifications required for the above said post are as under:

Note:- Working knowledge of Punjabi is essential. In case a candidate has not passed Punjabi at the Matriculation (10th) level, he/she shall be required to pass Punjabi language proficiency test equivalent to Matriculation standard by appearing in the examination conducted by the Punjab School Education Board or the Department of Languages, Government of Punjab within a period of six months from the date of appointment. However, if no such examination is conducted within the said period, the candidate shall be required to appear in and pass the same in the next available examination conducted by the said Board/Department.

6. Important instructions for candidates:-

- a. Only eligible candidates will be called to participate in the selection process **Annexure-A**. Intimation in this regard will be given via emails. A notice in this regard will also be uploaded on the website: <https://dit.punjab.gov.in/>. The applicants may, therefore, go through all the terms and conditions carefully before applying for the post. The onus of checking the website regularly shall be on the applicant.
- b. Applications without the proof of deposit of fee (non-refundable) and / or not reflecting in the PSeGS account are liable to be rejected summarily without any intimation. Incomplete/ineligible applications are also liable for rejection without intimation.
- c. For determining candidature, eligibility and selection criteria, the decision of the PSeGS shall be binding and mere application does not entitle a candidate the right to participate in the final selection process. Only the candidates found to be eligible shall be called to appear for further evaluation process and interview. Any candidate found to be lacking the basic qualifying criteria can be disqualified at any stage. No communication for rejection of candidature shall be issued.
- d. The decision of the CEO, PSeGS in all respects shall be binding and final.
- e. PSeGS reserves the right to defer, cancel or postpone the selection process at any time without assigning any reasons.

Marks based on %age in qualifying degree Aggregate %age in required base qualification divided by 5 (rounded upto 1 decimal point) For example: A candidate has completed his B.Tech with 65.72% and M. Tech. with 69.38%. Then the marks awarded would be as under: Required base qualification: B.Tech. (%age: 65.72) Marks awarded = $65.72 / 5 = 13.1$.	20
2.	Marks based on additional relevant qualification(s): For each additional relevant qualification (degree/diploma/certificate of more than 6 months), over and above the required base qualification, 5 marks would be awarded subject to maximum of 10 marks	10
3.	Marks based on additional relevant experience: For each completed year of additional relevant experience (over and above the required relevant experience), 1 mark would be awarded subject to a maximum of 10 marks	10
4.	Marks based on relevant experience in Government of Punjab: For each completed year of relevant experience in any organization of Government of Punjab, 1 mark would be awarded subject to a maximum of 5 marks	5
5.	Marks based on relevant experience in Government: For each completed year of relevant experience in any organization of Centre / State Government, 1 mark would be awarded subject to a maximum of 5 marks	5
