### 3. Age limit:-

**3.1 Between 20 and 27 years as on 01.06.2026** (as per the Recruitment Rules for the post of Sub-Inspector of Police (Male), Police Department (IRBn)) the last date for applying through online. Age limit is relaxable in respect of MBC, SC, Ex-Servicemen, and In-service officials as detailed below:-

### 4. Mode of Recruitment / Pattern of Examination:-

The candidates shall undergo the following tests as a part of the selection process:-

#### i) Physical Standards Test (PST):-

Physical Standard	Eligibility condition

Chest	81-86 cms. (with minimum expansion of 5 cms.)
Weight	Body Mass Index (BMI) should be 18.50 to 29.9 kg/m <sup>2</sup>

#### ii) Physical Endurance Test (PET):-

Those candidates who qualify the Physical Standards Test (PST) shall undergo Physical Endurance Test(PET):-

Stage	Events	Minimum Standard to acquire
Stage-I	100 metres run	15.00 seconds
Stage-II	Long Jump	3.80 metres
Stage-III	High Jump	1.20 metres
Stage-IV	800 metres run	2 minutes and 50 seconds

**Note:-**

- (1) All the above events are compulsory.
- (2) Each stage is a qualifying stage by itself for the next stage i.e. only the candidates who qualify in Stage -I will be eligible for Stage-II and so on.
- (3) Three chances will be given to qualify in the long jump and high jump.
- (4) Ex-servicemen will not be required to pass Physical Endurance Test. They will be eligible to appear for the Written Competitive Examination, if they possess the minimum physical measurements / standards.

**Appeal:**

The appeal made by any candidate on the same day of the Physical Standard Test and Physical Endurance Test will be examined and the decision of the Chairman of the Appeal Board in respect of the appeals shall be final.

**iv) Written Competitive Examination:-**

- a) Only those candidates who qualify in Physical Standards Test / Physical Endurance Test shall undergo a Written Competitive Examination (Combined Graduate Level Examination-2026).
- b) The syllabus shall be as prescribed for Paper-I and Paper-II (A) under para "2-Combined Graduate Level Examination" in Annexure-I to the Notification dated 13.03.2026.
- c) The Question Papers, Paper-I and Paper-IIA shall be Bilingual in English and Tamil / Telugu / Malayalam.
- d) The candidates should indicate the choice of the language in which they prefer to write the examination (in the on-line application). The question on English language, grammar, comprehension or literature etc., if asked, shall not be translated in any regional languages.
- e) Applicants are strictly instructed to go through Advertisement No. 01/CGL/PEA/2026, dated 13.03.2026, issued by this Authority, for detailed instructions regarding **syllabus, examination pattern, negative marking, weightage of marks, answer key publication and key challenge, minimum qualifying marks etc.**

**v) Date and Venue of PST, PET & Written Competitive Examination (Combined Graduate Level Examination-2026):-**

- a) The PST and PET will be held in Puducherry only.
- b) The Written Competitive Examination(Combined Graduate Level Examination-2026) will be conducted in all four regions subject to availability of adequate number of candidates from a particular region.
- c) The exact date, time and venue of the said tests will be intimated in due course in the recruitment website and also in leading News Papers.

**vi) Medical Examination:-**

**vii) Training and Probation:-**

- (a) The candidates who have been selected for the post of Sub-Inspector of Police (Male), IRBn, will remain on probation for a period of two years. They shall undergo Basic Training for one year in any of the Police / CAPF Training Centres in India and Phase-II Training as per raising guidelines of IRBn. The progress of training will be assessed through periodic exams.
- (b) During the period of probation, if it is found that the performance of the trainee is unsatisfactory, suitable action, including his discharge from the service, will be taken under the rules.
- viii)** The selected candidates are liable to be posted anywhere in India.
- ix)** **The closing date of receipt of online application is 3.00 PM on 01.06.2026.**
- x)** Applicants are advised to carefully read all the instructions, terms and conditions given in the Advertisement No. 01/CGL/PEA/2026, dated 13.03.2026, issued by this Authority before applying for the post.

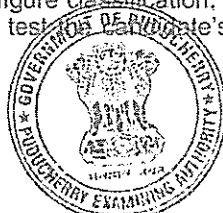
#### 1. Guidance on the Topics generally covered by the Written Examinations:

These are only indicative topics and syllabi. Questions may be asked from any topics appropriate for the Educational Qualification level prescribed and shall test the ability of the candidate's intelligence and general awareness of the environment in and around him / her and its application to the society.

It may include questions on current events and of everyday observations expected of an educated person and may include questions on History, Politics, Constitution, Sports, Art & Culture, Economics and Commerce, Everyday Science, Social Science, Scientific Research, National / International Institutions.

General Intelligence & Reasoning Ability / Quantitative Aptitude may include questions of both verbal and non-verbal types.

It may include questions on analogies, similarities, differences, space visualization, problem solving, analysis, judgment, decision making, visual memory, discrimination, observation relationship concepts, arithmetical reasoning, verbal and figure classification, arithmetical number series, etc. The test may also include questions designed to test the candidate's abilities to deal with abstract ideas

and symbols and their relationship, arithmetical and numerical abilities and other analytical functions.

The questions on arithmetical and numerical abilities will cover number systems including questions on simplification, decimals, data interpretation, fractions, L.C.M., H.C.F., ratio & proportion, percentage, average, profit & loss, discount, simple & compound interest, mensuration, time & work, time & distance, tables & graphs.

The questions on English language and grammar / comprehension will test the understanding and knowledge of English language grammar, literature and may be based on spot the error, fill in the blanks, synonyms, antonyms, spelling / detecting misspelled words, idioms & phrases, one word substitution, improvement of sentences, active / passive voice of verbs, conversion into direct / indirect narration, shuffling of sentence parts, shuffling of sentences in a passage, close passage & compensation passage.

The questions on ethics and morality shall include theories and concepts of moral values, judgment or decision on situations requiring moral and ethical awareness and aptitude. Questions on computer knowledge shall test the general and specific knowledge about the computers, hardware and software, various applications and its operations.

In case of specific subjects indicated, the question may be asked to test knowledge of the candidates in that subject as per the level of educational qualification prescribed. There shall be no specific sectional allocation of questions and emphasis may vary depending on the topics covered.

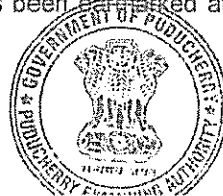


