## Age Limit:

- (a) Age will be calculated with reference to 01.01.2024 and should have attained the age of 18yrs to 32yrs.Upper age limit is relaxable by 5 years for SC/ST.
- (b) The date of birth to be accepted by the DSC is as entered in the Matriculation/Secondary Leaving Certificate/or a Certificate recognized by an Indian University as equivalent to Matriculation or an extract from the official Registers duly Certified by the proper authority of Board of School Education. Documents other than these will not be accepted by the DSC.
- (c) No age bar in respect of regular Government employee who entered Government service within the prescribed age limit and they apply through proper channel with no objection certificate (NOC) from concerned department.
- \* \* For person with disabilities (PWDs) age is relaxable by 10 years (15 years for ST/SC) applicable to posts where reservation is admissible to PWDs as per Government Notification.

Reservation of vacancies: As per latest guidelines of Reservation policy of the Govt. of Meghalaya. As directed by the Government of Meghalaya vide letter NO PER(AR) 21/2024/2 Dated 16<sup>th</sup> February 2024,all applicant shall be allowed to appear in the examination and scrutinizing of documents will taken up only after the candidates have cleared the written examinations. Merely clearing the written examination will not be entitled the candidate to appear for the interview as they may still be rejected during scrutiny of documents if not found eligible. Candidates are advised to carefully go through the eligible criteria prescribed for each post such as educational qualification, age physical standards etc and satisfy themselves that they are eligible for the post before applying. Original Certificates are to be produced at the time of personal interview. Candidate failing to produce the aforementioned documents on the day of interview will have their candidature immediately disqualified.
