#### **GENERAL & MINIMUM QUALIFICATIONS**

#### Direct recruitment -

A) Qualification for Arts, Sciences, Social Science, Commerce, Performing Fine Arts & Arts, Journalism & Mass Communication/B.Voc. & Yoga

#### Post – ASSISTANT PROFESSOR

A.

- 1) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET:

*Provided* the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the existing Ordinances/Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/ seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

#### Note:

- 1) The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.
- 2) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.
- B) Qualification for M.B.A.

First Class or equivalent in Master Degree in Business Administration or equivalent and 2 years relevant Experience is desirable.

C) Qualification for Technology

M.Sc. Chemistry, M. Pharmacy, M.Tech. in Cosmetic Technology

D) Qualification for P.G. Diploma in Nutrition & Dietetics

Essential: M.Sc. Food and Nutrition or M.Sc. Home Science (Food & Nutrition)

Or M.Sc. Dietetics & Nutrition or Any Medical Graduate (MBBS/BAMS/BHMS) with PG Qualification in Nutrition & Dietetics or MPH (Nutrition)

Desirable: SET/NET/M.Phil/Ph.D. for candidates with P.G. Qualification in Food and Nutrition/Home Science/Dietetics and Nutrition, For Medical Graduates without P.G. Qualification in Nutrition and Dietetics, Teaching experience in Biochemistry/Physiology

#### **General Instructions for Candidates:**

- 1. All posts are to be filled on purely temporary contract basis for Academic Year 2022-23.
- 2. The minimum qualification for post is as per UGC/AICTE/Government norms as the case may be.
- 3. A relaxation of 5% may be provided from 55% to 50%, at the Master's level for S.C./S.T./VJ-NT/SBC/O.B.C. (Non-creamy Layer) / Differently abaled category (Divyang).
- 4. Relaxation of 5% may be provided, from 55% to 50%, to the Ph.D. holders, who have passed their Master's degree prior to 19<sup>th</sup> Sept., 1991.
- 5. 4% reservation will be observed for PWD (Divyang) candidates as per Government Resolution dt. 29.05.2019.
- 6. 30% reservation for women shall be observed as per Government norms.
- 7. As per Government Resolution VJ/NT Category are interchangeable.
- 8. As the nature of appointment is purely temporary, if the reserved candidates from respective categories are not available for the aforesaid reserved posts these posts will be filled in through open candidates.
- 9. Candidates from reserved category, who are domiciled outside the Maharashtra State will be treated as Open Category candidates as per Government resolution.
- 10. Application fee is Rs. 500/- (non-refundable) for General, EWS candidates and Rs. 250/- (non-refundable) for SC/ST/VJ-NT/SBC/OBC/PWD (Divyang).
- 11. Mode of Payment: Payment should be transferred through online/NEFT/RTGS/QR Code/Debit Card/Credit Card/UPId only in the name of Finance & Accounts Officer, Punyashlok Ahilyadevi Holkar Solapur University, Solapur.
- 12. The candidates are advised to fill-in the prescribed application form completely in legible handwriting or in typewritten form. Incomplete and illegible application forms and those that are not in the prescribed format shall be rejected.
- 13. Separate application should be submitted for each post.
- 14. The application form shall be rejected and no communication in this regards shall be made in case; a) the candidate does not possess essential academic qualifications and/ or experience, b) the candidate exceeds the maximum age limit prescribed for the post c) self-attested copies of essential documents and certificates such as qualifications, experience, age are not enclosed, d) the details of the payment of the requisite fee is not enclosed, e) If the application is not signed by the candidate.
- 15. The essential qualification, experience and age of the applicant shall be taken into consideration as on the last date of submission of application form.
- 16. The Punyashlok Ahilyadevi Holkar Solapur University, Solapur reserves all rights regarding increase or decrease in no. of posts, correction, addition or deletion in advertisement and cancellation of whole advertisement.
- 17. Any change/modification in the advertisement shall be uploaded on the university website http://su.digitaluniversity.ac → Employment Opportunity and sus.ac.in → Activities/ Services → Employment Opportunity only. Therefore, the applicants are instructed to check the website regularly.
- 18. The University reserves the right not to fill up any post(s) even after selection of a candidate(s) thereof.
- 19. Candidate must furnish the detailed information regarding suspension, removal from previous service or any criminal prosecution against him/her or nature of punishment ordered thereof.

- 20. Government employee and the staff working under the Universities and other institutes/organizations should necessarily submit their application through proper channel.
- 21. If at any time after appointment, it is found that the candidate has submitted false information document, his/her appointment shall be terminated without prior information/notice
- 22. Fix Pay: 1) Qualification NET/SET/Ph.D./M.C.A. & GPAT holder candidates Rs. 22,000/- per month, ii) others candidates Rs. 18,000/- per month on consolidated pay, iii) for M.B.A. as per sixth pay commission.
- 23. A candidate furnishing incorrect or false information shall stand disqualified at any stage.
- 24. The interested candidates should attend on their own cost to the interview on above date & time, along with necessary original documents (one set of Photostat attested copy) in Management Council Hall of the University. The candidates should report before 01 hour to scrutinize the documents & Application form.
