Note: As per CSIR letter NO. 5-1(342)/2017-PD, dated 02.09.2024 engagement of Project Staff shall be co-terminus with the term of the Project subject to the condition that the total period of engagement of a Project Staff in different projects either in the same Lab / Instt. or different Lab / Instt. of CSIR taken together shall not exceed 6 years in any case. ### i. Minimum Educational Qualifications:

### A. Trade (ITI) Apprentices:

• Passed out candidates in the particular trade of NCVT pattern designated by Director General of Employment & Training (D.G.E.&T) and who have registered with Regional Directorate of Apprenticeship Training (RDAT), Chennai will only be considered for selection.

### B. Technician (Diploma)/ Graduate (Degree) Apprentices:

- Full time graduate degree granted by a recognized university / Institutions in relevant discipline.
- Diploma in Engineering / Technology in full time granted by a State Council or Board of Technical Education Established by a State Government/University/Institutions in relevant discipline.

### ii. OTHER ELIGIBILITY REQUIREMENTS:

- 1. Graduate/ Technician candidates who have passed the qualifying exam in 2021/2022/2023/2024 are only eligible.
- **2.**Candidates who have registered themselves in the Apprenticeship Portal for Apprenticeship and who fulfill the eligibility criteria as indicated above will be considered for appearing in the walk-in-interview.
- 3. Candidates should not have undergone or presently undergoing Apprenticeship Training in CSIR or elsewhere.
- 4. Candidates should not have experience of one year or more in any job.
- 5. Sandwich diplomas, private diploma, part time/Distance/short term/certificate cources etc., are not acceptable.

### iii. AGE:

**ITI**: Minimum 14 years for ITI Apprentices as on date of interview.

**Technician/Diploma**: Minimum 18 years and maximum 24 years for Technician/Diploma Apprentices as on date on interview.

**Graduate/Degree:** Minimum 21 years and maximum 26 years for Graduate/Degree Apprentices as on date of interview. **Relaxation:** (Relaxation by 5 years for SC/ST, 3 years for OBC, for the posts reserved for them). Candidates belonging to PWD Categories shall be given age relaxation upto 10 years (upto 15 years for SC/ST and upto 13 years for OBC (Non-Creamy Layer) Candidates.

### iv. **RESERVATION:**

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD will be followed. Those who are claiming reservation under SC/ST/OBC/PWD shall provide certificate as per Government Standard format, failing which their claim for reservation will be considered as 'General' category only. BC candidates claiming OBC (Non creamy layer) category should submit OBC (NCL) certificate as per the approved (OBC-NCL) format from the certificate issuing authority.

### VI. Terms & Conditions for JRF/Project Associate-1 & II:

- i. These are purely temporary positions.
- ii. Number of positions required is indicative in nature, there may be increase/decrease in the number based on the requirement.
- iii. In the event of number of the applicants being, large, CSIR-SERC will adopt shortlisting criteria to restrict the number of applicants to be called for Interview to a reasonable number by any one or more of the following methods:
  - a) On the basis of higher educational qualifications than the minimum prescribed in the advertisement.
  - b) On the basis of higher experience in the relevant field than the minimum prescribed in the advertisement
  - c) On the basis of Marks obtained in the academic qualification


