Job Description		1. <u>Conducting Risk Assessments</u> Regularly conduct risk assessments to identify potential hazards in the workplace. This includes analysing current work processes, equipment, and environmental factors that may pose a risk to employees.	
		2. <u>Developing Safety Policies</u> Responsible for creating and updating safety policies that align with local, national, and international regulations. These policies guide employees on safe practices and procedures.	
		3. Ensuring Compliance with Safety Regulations Ensure that the company complies with all relevant safety regulations. This includes keeping up-to-date with any changes in legislation and implementing necessary adjustments in the workplace.	

# 4. Conducting Safety Training Programs

Develop and deliver training programs to educate employees on safety practices. This training helps to minimize risks and ensures that everyone knows how to respond in case of an emergency.

# 5. Investigating Accidents and Incidents

Conducting a thorough investigation when an accident or incident occurs. This involves identifying the root cause, documenting the findings, and recommending corrective actions to prevent future occurrences.

# 6. Implementing Emergency Procedures

Responsible for ensuring that all safety equipment, such as fire extinguishers, alarms, and protective gear, are in good working condition and readily available.

#### 12. Promoting a Safety Culture

Promote a culture of safety within the organization. This involves encouraging employees to prioritize safety in their daily activities and to report any concerns.

# 13. Managing Safety Documentation

Maintain accurate and up-to-date documentation related to safety policies, procedures, and incidents. This documentation is essential for compliance and audit purposes.
