- 1) After Physical Test, the list of eligible candidates for Onscreen Certificate verification will be published in the ratio of 1:4.
- 2) Mere inclusion of the register number of a candidate will not imply that his/her candidature has been fully considered for next stage of selection.
- 3) The candidates whose register number is found in the above list have been admitted provisionally to the Physical Test (Walking Test) in the ratio 1:10 based on the marks obtained by them in the Written Examination (OMR and CBT) and with reference to the rule of reservation of appointments.
- 4) The admission of candidates to Physical Test (Walking Test) is provisional subject to verification and acceptance of the claims as made in their online application towards Age, Educational Qualification, Physical Qualification, Communal category, Differently Abled category, PSTM, etc., through original documents. If any of their claims are found to be false or incorrect, their online application will be rejected, their provisional admission to Physical Test will be cancelled and they will not be admitted to the next stage of selection.
- 5) The candidates who have appeared for the Written Examination and whose register number is not found in the above list have not been admitted to the Physical Test (Walking Test). Separate communication in this regard will not be sent to those candidates.
- 6) The admission of the above candidates to the Physical Test is purely provisional subject to the final orders to be passed in W.P.No.31008 of 2022 and other cases, if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court, relating to this recruitment.
