Sukoon is currently operational in 6 centers in Mumbai, 2 centers in Aurangabad and one center each in Ahmednagar and Yavatmal.

**Job Profile:**

The candidate shall report directly to the Project Directors and shall be responsible for the following:

- Providing supervision to a team of counsellors for their ongoing counseling work
- Overseeing the documentation processes of counselors
- Assisting with training and handholding of counsellors/new recruits

- Mapping training needs of counsellors
- Mapping the progress of team members and assigning responsibilities within the team
- Organizing and attending debrief on a regular basis

**Qualifications:**

- Possess a Master's Degree in Counseling / Clinical psychology from a UGC-recognized University have 2-3 years of counselling experience  
OR
- M.Phil in Clinical Psychology from RCI recognized University or Ph.D in Psychology with specialisation in Clinical/Counselling Psychology.
- Practitioners with prior experience in providing supervision and training will be preferred.
- Preference will be given to those candidates who have additional qualifications such as having completed specialized courses in Couples and Family Therapy OR demonstrating direct experience working as a couples/family therapist.
- Preference will be given to candidates who have an experience of working with legal settings.
- The candidate should have proficiency in English, Hindi and Marathi.
