In order to achieve this, TISS Tuljapur has evolved a four-dimensional programme comprising teaching, training, field action and research & documentation. It has built a strong team of multidisciplinary faculty drawn from social work, philosophy, sociology, economics, agriculture, anthropology, psychology, geography and other related disciplines.

The TISS, Tuljapur Campus invites application for **One post of Assistant Professor** to be filled on contract basis, initially for a period upto 31 May 2023 and extendable based on performance of the candidate and requirement of the Institute.

Verification of documents: The shortlisted candidates are required to send scanned copies of their coloured passport size photograph, self-attested photocopies of relevant certificates in support of the essential qualification & experience. Original certificates will be verified only for the selected candidate at the time of appointment.

Remunerations: Consolidated salary of Rs. 63408/- p.m. (Pay Band Rs. 15600 – 39100 ; AGP Rs. 6000/-) in 6th CPC as approved by funder.

Eligibility Criteria:

Educational Qualification: Eligibility:

A.

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in English from an Indian University, or an equivalent degree from an accredited foreign university. The candidate is expected to teach English language and literature to the students of social sciences at the undergraduate level. English language teaching includes teaching academic reading, writing and presentation skills Teaching literature should be primarily derived from various genres of writings within the context of India. The candidates should be able to use adequate pedagogical skills to teach language and literature in a way that should be in conversation with various social science disciplines. They should be able to use multiple sources of texts as part of their pedagogical skills

ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of 'Assistant Professor' subject to the or equivalent positions in Universities/Colleges/Institutions fulfilment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which

NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

B. The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- i. Quacquarelli Symonds (QS)
- ii. the Times Higher Education (THE) or
- iii. the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

The desirable qualifications and experience:

The candidates having Ph D, minimum of two years of work experience/research/teaching in the area of English (language and Literature) and who are well conversant in Marathi language and can teach basic functional communicative Marathi to the undergraduate students will be given preference

Other Conditions:

- The Institute reserves the right to relax qualifications of the candidate based on the work experience.
- The Institute reserves the right to invite persons for interview who may not have applied for as per the above procedure and not fill up the vacancy advertised.
- Since applications received may be short listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for interview.
- The post is unreserved, but candidates belonging to reserved category can apply.
- □ No queries or correspondence regarding issue of call letter for interview/selection of candidates for the post will be entertained at any stage and canvassing in any form is strictly prohibited and will lead to the candidate being debarred from consideration for the post.
- The candidate under employment must bring 'No Objection Certificate' from their employer to appear for interview.
