The LMRF is actively engaged in policy advocacy in areas such as formal and informal work, skill development, technology and labour, internal and external labour market, and livelihoods.

Key Roles and Responsibility:

The Research Officer (RO) at LMRF is responsible for effectively managing all the activities anchored in multiple cities including the current centres at Mumbai by having an overall view of the vision of LMRF. S/He is also responsible for Planning, organising, managing and ensuring the execution of the upcoming plans, projects and aspirations of LMRF ensuring that substantive work programmes and program activities which are carried out smoothly and promptly:

- The RO will assist in the research projects and the programmes of the LMRF
- The RO will also involve in teaching assistance to academic programs of LMRF (BS Analytics and Sustainability Studies, MA/MSc in Analytics, Executive Post Graduate Diploma in Data Analytics) and prepare study materials for the programmes and administration-related activities
- The RO will be involved in teaching programs offered by LMRF (PAR Certificate Program, MIDP Programs, FDP Programs and other programs which are planned)
- The RO will also involve in developing study materials for the programmes and administration-related activities
- The key responsibilities include assisting the faculty and coordinator to run the Academic programme of LMRF at Mumbai and various LMRF projects. This requires Coordination with coordinators at Mumbai and other locations
- Co-ordinating the academic requirements for EPGDA (Executive Post Graduate Diploma in Analytics) of LMRF. The candidate will have to be present in the campus on Saturday and Sunday as and when required

Essential Qualification – Good academic record with at least 55 % of the marks or an equivalent grade in a point scale wherever the grading system is followed at the Masters in Social Sciences.

Application Fee: An application Fee of Rs 500/- is to be paid online. Application fee for SC/ST/PWD candidates will be Rs 125/-, if they upload the required Certificate in the Online Application Form. Women applicants are exempted from the payment of application fee. The application will be valid only on receipt of the application fee for those who are required to pay. The fee, once paid, shall not be refunded under any circumstances.

Other Conditions.

(a) The Institute reserves the right not to fill up the vacancy advertised. The Institute reserves the right to invite persons for interview, who may not have applied for the vacancy as per the above procedure.

(b) Since applications received will be short listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for interview.

(c) The position is unreserved, but candidates belonging to reserved category are encouraged to apply.

(d) No queries or correspondence regarding issue of call letter for interview/selection of candidates for the post will be entertained at any stage and canvassing in any form is strictly prohibited and will lead to the candidate being debarred from consideration for the post.

(e) It shall be the responsibility of the candidate to assess his/her own eligibility for the post, for which he/she is applying in accordance with the prescribed qualifications, experience etc, and submit his/her application duly filledin along with the desired information and documents as per the advertisement. Suppression of factual information, supply of fake documents, providing false or misleading information or canvassing in any manner on the part of the candidates shall lead to disqualification. In case it is detected at any point of time in future, even after appointment, that the candidate was not eligible, his/her appointment shall be liable to be terminated forthwith as per this clause.

(f) In case of any ambiguity in the Recruitment Rules in general and eligibility in particular for any post, the decision of the Institute shall be final.

(g) The Institute reserves the right to relax qualification(s) of the candidate based on the work experience.

(j) The post is purely contractual and the term of the Contract Position will be one year, an extension, if any, will be given after assessing the suitability and performance of the selected candidate post-one-year tenure on the post.
