**Qualification:**

- Graduate from a recognised University/Institute with an aggregate of 60% marks.
- Diploma/Degree/Certificate course in Management or Administration from a recognised University/Institute.
- Proficiency in use of personal computers and applications.

**Experience:**

5 years' service at Level 6 and /or Level 7 and /or Level 8 or with equivalent TME (total monthly emolument).

**Desirable:**

- Experience in recruitment section of Government Departments and Institutes; hands on experience in maintaining all reservation roster as per Government of India rules; compassionate appointments; pay fixation and pay protection; generating recruitment reports as per the requirement of various Government agencies.
- Knowledge of Government of India Rules; CCS Rules, FRSR, Establishment, Services Rules and Welfare matters.
- Candidate should be able to run a responsible recruitment while ensuring speed, quality and attention to details.
- Skill in handling oral and written official correspondence.
- Knowledge of data management software.

**Mode of Recruitment: Written Test, Skill Test and Personal Interview**

**General Information:**

1. The above post is tenable at TIFR, Colaba, Mumbai.
2. Selected candidate for the above post is liable to be transferred to other Centers/Field Stations of the Institute, if required.
3. Selected candidate for the above post will be required to work on Saturday/Sundays and holidays, as per the exigencies of the Institute.
4. The applicant's age must not exceed the prescribed limit as on the closing date for receipt of applications. Age relaxation as per rules.
5. Selected candidate for the post will be governed by the National Pension System applicable in the Institute [unless already governed by CCS (Pension) Rules 1972].
6. Post for general category (Unreserved) – SC/ST/OBC/EWS/PwBD candidates can also apply.
7. **Applications from the candidates will be accepted ONLY ON-LINE**
  - i. Applicants from Government/Semi-Government/ Public Sector Undertaking/ Autonomous bodies, if called, will be able to participate in the recruitment process only upon submission of No Objection Certificate (NOC) from the competent authority, at the time of selection process.
8. Incomplete online applications shall not be considered.
9. **On-Line applications must be submitted by June 13, 2026.**
10. The candidates are required to produce the following original documents with copies at the time of recruitment process:
  - a. Printout of online application form.
  - b. Identity Proof (Aadhaar Card / Election Card / PAN Card / Passport / Driving License).
  - c. Date of birth/Proof of age.
  - d. NOC from current employer if working in Government/Semi-Government/ Public Sector Undertaking/ Autonomous bodies.
  - e. Educational Qualification (all mark sheets and certificates).

In case Universities/Board award letter grades/CGPA/CGPI/OGPA, the same will have to be indicated as equivalent percentage of marks as per the norms adopted by the University/Board. In the absence of the same, the candidature will not be considered. While submitting original documents for verification, the candidates will have to produce the norms of the University/Board for conversion of grades/CGPA/CGPI/OGPA to equivalent percentage of marks.
  - f. Experience certificate/s.
  - g. Character certificates from two respectable people.
  - h. SC/ST/OBC/EWS & PwBD certificate (wherever applicable) in the Government of India format.
  - i. PwBD candidates applying for the unreserved post should be suffering from not less than 40% of the disability for the benefit of age relaxation. Candidates will have to submit a Disability Certificate issued by the competent authority in the prescribed format.

11. Outstation candidates called for recruitment process for the above post will be paid single first class (non-air conditioned)/III Tier A/C return fare for the journey by the shortest route from the nearest railway station of their place of residence on the production of photocopies of onward and return journey tickets.

The Institute reserves the right to restrict the number of candidates for the recruitment process to a reasonable limit on the basis of qualifications and experience higher than the minimum prescribed in the advertisement. Mere fulfilling the essential and desirable qualifications and experience will not entitle an applicant to be called for the recruitment process. The Institute reserves the right not to fill any/some posts herein advertised. Canvassing in any form shall disqualify the candidate.

13. Before applying for the post, the candidate should ensure that they fulfill the eligibility and other criteria. Recruitment authorities would be free to reject application not fulfilling the requisite criteria, at any stage of recruitment, and if erroneously appointed, such candidates shall be liable to be terminated from service, if appointed.
