The Uttar Pradesh University of Medical Sciences (formerly U.P. Rural Institute of Medical Sciences & Research), Saifai, Etawah (established by the Government of Uttar Pradesh under Act No. 15 of 2016), invites applications from eligible Indian citizens for the teaching post of Associate Professor in the Faculty of Pharmacy. A total of two vacancies are available, one each under the SC and UR categories. The details of qualification, terms and conditions are as under:-

Qualifications and Experience :-

i. Essential.

- 1- A basic degree in Pharmacy (B. Pharm)
- 2- Registration as a Pharmacist under the Pharmacy Act 1948, as amended from time to time, including any succeeding enactments.
- 3- A PhD Degree with first class at Bachelor's or Master's Degree in the appropriate Branch of specialization in Pharmacy, and experience of 08 years in teaching, research and / or Profession at the level of Lecturer/Assistant Professor or equivalent grade excluding period spent on obtaining the research degree.

OR

ii. In the event of the candidate is from industry and the profession, the following shall constitute as essential:

- 1- First Class Master's Degree in the appropriate branch of specialization in Pharmacy.
- 2- Significant professional work which can be recognized as equivalent to a PhD Degree in appropriate branch of specialization in Pharmacy and industrial/ professional experience of 08 years in a position equivalent to the level of Lecturer/ Assistant Professor,

Provided that the recognition for significant professional shall be valid only if the same is recommended unanimously by a three member committee of experts appointed by Vice Chancellor of the University.

iii. Desirable:

1. Teaching, Research industrial and / or professional experience in a reputed organization.
2. Published work, such as research papers, patents filed/ obtained books and / or technical reports and experience of guiding the project work, dissertation of post graduate or research students or supervising R&D projects in industry.

General terms & conditions:-

1. Exceptionally qualified candidates having meritorious records and specialized experience may be given advance increments on the recommendation of the selection committee.
2. Selections may not be made for all the advertised posts.
3. Attested copies of testimonials/documents in support of age/date of birth, educational qualification, experience, publications (as per latest norms of respective professional governing bodies) and caste must also be enclosed with the hard copy of the application.
4. Envelope should be superscripted with the Advertisement No. and name of the post.
5. The Vice Chancellor reserves the right to cancel the Advertisement without assigning any reason and in that case application fee will not be refunded.
6. Reservation and Age relaxation for all the reserved category candidates will be applicable to domicile of Uttar Pradesh as per U.P. Government rules.
7. In case of permanent employees of Uttar Pradesh Government who have rendered not less than regular and continuous service in the relevant field, relaxable upto maximum period of 5 years as per GO of govt. of UP Karmic Anubhag-4 Ref. No-2 EM/2001-ka-4- 2013 dated 27-08-2013.
8. No TA/DA shall be admissible for attending the Interview.
9. Applicants working in Government/semi-government undertakings/autonomous/private institutes should apply through proper channel or produce a no-objection certificate at the time of interview.
10. Maximum age will be calculated as on 01 January, 2025.


