1. Candidates must submit their applications online at: <https://vnsgurec.samarth.edu.in/>. Only online applications accompanied by the required uploaded attachments will be considered.
2. The Last Date for submission of online application is **on or before 05/01/2026 up to 06:00 p.m.**, and the last date for receipt of hard copies of the applications along with attachments is **on or before 15/01/2026 up to 06:00 p.m.**
3. Applications received after the last date and time mentioned above will be rejected.
4. The regulations/norms and other service conditions prescribed in the present advertisement are as per the Notification **UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018 (18th July, 2018)** and subsequent amendments from time to time till the last date of receiving application.
5. Candidates needs to follow the guidelines prescribed by UGC vide Notification dated 18th July 2018 and subsequent amendments from time to time till the last date of receiving application.
6. The candidates must fulfill all eligibility conditions as of the last date of receiving the application.
7. Applicants must send/submit **02** hard copy of the application, after submission of online application form, to the office of Registrar, Veer Narmad South Gujarat University, Surat on or before the last date and time for receiving. The hard copy must be accompanied by all Self-Attested testimonials and supporting documents relating to applicant's Academic/Research Score to substantiate his/her candidature.
8. Applicant should also submit a self-attested photocopy of any Government issued proof of Identity.
9. The prescribed application fee is Rs.1500 /- (One Thousand Five Hundred only) for Unreserved Categories and 600/- (Six Hundred only) for Scheduled Caste (SC)/ Scheduled Tribe (ST)/ Socially and Economically Backward Class (SEBC)/ Economically Weaker Section (EWS) candidates. The fee must be paid online only.
10. Persons with Benchmark Disability (PwBD) are fully exempted from payment of the prescribed application fee upon submission of the relevant Disability Certificate issued by the competent authority as per the policy of the Government of Gujarat.
11. Bank charges towards the online payment service as applicable will be additionally payable by the candidate.

20. In case of consultancy, supportive documents as applicable such as nature of consultancy, role and responsibility of the applicant pertaining to said consultancy, revenue sharing document, copy of MOU and any other relevant document.
21. Applicants awarded degrees (apart from Doctorate Degrees) by Foreign Universities shall be required to submit an Equivalence Certificate issued by the Association of Indian Universities, New Delhi.
