You are hereby offered an engagement for the post of Lower Division Clerk on purely contractual basis in West Bengal Police Directorate on the following terms and conditions:-

- (1) You will be engaged on purely temporary & contractual basis upto 31.10.2021.
- (2) In addition to the normal duties assigned to you, you may also be called upon from time to time to do any other work of this office and no extra remuneration will be admissible for such work.
- (3) Your responsibilities will be fixed by the Competent Authority of West Bengal Police Directorate.
- (4) You shall maintain secrecy in relation to business, administration, accounts etc. and such other official matters which may be assigned to you from time to time. You will extend complete loyalty to this office and you shall not share any information relating to your responsibility with any other party unless authorized in writing by your employer.
- (5) You should not directly or indirectly engage yourself in any other services involving outside agencies whatsoever without the prior consent of this office administration.
- (6) You will be paid a consolidated remuneration @ Rs. 10,000/- (Rupees ten thousand) only per month or the remuneration as applicable to a re-employed employee as per G.O. No. 3951-F Dt. 27.05.2009 whichever is minimum.
- (7) You will be allowed leave as per the provision in rule 213 of West Bengal Service Rules, Part-I since you have been engaged on contract basis against sanctioned post only.
- (8) Your engagement may be terminated on one month's notice from either side.
- (9) No criminal case is pending or reported against.
