5. Candidate who will apply for more than one post have to submit separate application for each post.
6. Application form for each individual post must be submitted in specified format along with photocopy of all the marks sheet & certificate.
7. Number of vacancies/ remuneration as mentioned under this advertisement may increase or decrease at the time of actual engagement.
8. Over aged and under qualification in the prescribed educational qualification shall be rejected.
9. 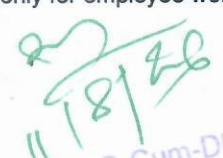
