ENGAGEMENT OF CONSULTANT

The Babasaheb Bhimrao Ambedkar University (A Central University) invites applications from retired Engineering Officers from Government/Autonomous bodies/Public Sector Undertaking/Technical Institutions for engagement as **Consultant** on full time basis as per following details.

GENERAL PROVISIONS:

- (i) In case of retiring Govt. servant, he/she should have been retired on the closing date of receipt of application for engagement of consultant.
- (ii) General instructions regarding terms and conditions for contractual appointment/engagement as issued from time to time by BBAU/UGC/MHRD Government of India will be applicable and binding on the Consultant(s). The Consultant appointment for BBAU, Lucknow shall be attached in any of its Campuses.
- (iii) The contractual appointment/engagement may be terminated at any time by the BBAU for unsatisfactory performance on notice of 15 (fifteen) days. In the case of any misconduct including, but not limited to, misappropriation, ~~negligence or causing loss~~ to University/Tarnish the image of University, the contractual appointment may be terminated forthwith without any prior notice.
- (iv) In case any Consultant desires to resign, he may do so by giving a notice of 15 (fifteen) days in writing. After expiry of the notice period, the consultant shall be relieved after handing over full charge of records to the relieving officer as decided by the BBAU.
- (v) University reserves rights to terminate the services of any consultant at any point of time with prior one month notice to him/her.
- (vi) The Consultant will furnish undertakings in regards to the truth and correctness of the information furnished by him/her, declaration of fidelity & secrecy and vigilance/ criminal proceedings against him/her as per prescribed format at the time of joining the duty.

- (vii) The engagement of the Consultant will be purely on Contract basis and appointment will not confer any right to the individual for regular /permanent appointment to the post in BBAU.
- (viii) The consolidated remuneration shall be payable, subject to periodical completion of work certified by the Controlling Officer. They will not be eligible for any other allowance in addition to the consolidated pay. He/She can, however, continue to draw their pension and relief on pension, as per their entitlement from their parent organization.
- (ix) They should not have attained the age of 62 years on the closing date of applications. The maximum age limit of Consultant shall not exceed 65 years during the period of their engagement. However, this age limit can be relaxable in the case with the approval of Competent Authority.
- (x) They will be governed by the Official Secrets Act, 1923, as amended from time to time and will not disclose to any unauthorized person(s) any information/data that may come to their notice during the period of their engagement as 'Consultant' in the Department. All such documents will be property of the Government.
- (xi) The Intellectual Property Rights (IPR) of the data collected as well as deliverables produced for the University shall remain with the University.
- (xii) Their attention is drawn to Central Vigilance Commission's circular no. 01/01/17 dated 23.1.2017 and circular no. 08/06/2011 dated 24.6.2011 regarding engagement of consultants. They will be completely accountable for any advice or any service rendered by them during their engagement in this University in view of norms of ethical business and professionalism.
- (xiii) They must act, at all times, in the interest of BBAU and render any advice/ service with professional integrity.
- (xiv) The consultants appointed by the University shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the University nor will they indulge in any activity outside the terms of the contractual assignment.
- (xv) They will complete the assigned task within the stipulated period as per the requirement of their controlling officers. They will not take up any assignment or contract which conflicts with the interest of the Government during the contract period.
- (xvi) No TA/DA shall be admissible to the Consultant(s) for joining/termination of the assignment. Consultant(s) will not be allowed any foreign travel at BBAU expense. The consultant shall undertake any tour within the country with the prior approval of the Competent Authority. Entitlement of TA/DA for tours within the country for attending office work shall be as follows:

- (xvii) Tax Deduction at Source (TDS) as admissible shall be deducted from the monthly remuneration of Consultant(s). A TDS certificate shall be issued by the concerned DDO.
- (xviii) Remuneration of Consultant would be negotiable. The remuneration would be decided on the basis of pay level, substantive position from where he has retired, experience, qualification etc.
- (xix) Consultant shall not be appointed as head of Section/Division and will not be treated as a replacement of any sanctioned designated position.
- (xx) BBAU has the right to cancel any advertisement for selection of consultant or not to proceed further in the matter. BBAU also reserves the right to accept or reject all or any of the applications without assigning any reasons whatsoever. The University also reserves the right to terminate the services of the consultant at any point of time by giving prior one month notice to him/her.

1. ELIGIBILITY CRITERIA:

The Consultant shall possess Master Degree in Civil Engineering with an excellent service record with reputed organizations which may be Central/State Govt./PSU/IIT/NIT/Central University/Technical Institution at the level equivalent to Superintending Engineer having experience in Development projects like Survey, Investigation, Designs, Construction & Maintenance, preparation of feasibility reports, DPRs of projects etc.

OR

The Consultant shall possess Master Degree in Civil Engineering with an excellent service record with reputed organizations which may be Central/State Govt./PSU/IIT/NIT/Central University/Technical Institution at the level equivalent to Executive Engineer (EE) with 5 years' experience as EE in the field of Survey like Investigation, Designs, Construction & Maintenance, preparation of feasibility reports, DPRs of WR projects etc.

2. PERIOD OF ENGAGEMENT:

- i. The engagement of a person as Consultant would be for a period of Six months or less depending upon the work to be assigned to him/her subject to the Consultant not exceeding the maximum age limit prescribed for engagement of Consultant. The engagement would be revised after six month and may be extended on satisfactory performance and requirement basis but it would not exceed one year at a time. The review of consultant will be done on year to year basis.

3. JOB SPECIFICATION:

The Consultant(s) are required to be appointed for attending to following works/responsibilities:

- (i) To supervise construction and maintenance work.
- (ii) To submit new proposals for construction of Academic Buildings.
- (iii) To expedite the HEFA proposals.
- (iv) To monitor the construction work and quality supervision.

- (v) To provide the consultancy in framing new guidelines, review of existing guidelines and any other matter of construction as and when they arise.
- (vi) Any other work as assigned by the Vice Chancellor or Authority of the University from time to time.

All the above works will be completed in the light of Central Govt. rules and rules and regulations of the University.

4. REMUNERATION:

The persons engaged under the above guidelines shall be paid an all-inclusive (including Transport Allowance) monthly remuneration Rs.40000-60000/- (fixed).

Note 1- The total monthly remuneration and the Pension drawn by the consultant will not be more than the Last pay Drawn by him calculated at the current rates of DA.

5. LEAVE:

The consultant shall be eligible for only one day leave in one month except holidays. The un-availed leave in a calendar month/year cannot be carried forwarded to next calendar month/year. The consultant shall not be eligible for earned leave/ half pay leave/RH and other leaves as applicable to permanent employees of BBAU.

BBAU would be free to terminate the services in case of Consultant remains absent, without intimation, for a period more than 15 days.

6. DISPUTE RESOLUTION:

Any arbitration, dispute, claim or controversy shall be subject to exclusive jurisdiction of Hon'ble Court in Lucknow, India.

7. LOGISTICS AND SUPPORT:

The consultant(s) would be provided working space, computer/internet facility and other necessities as deemed fit by BBAU Authority. If the consultant is from outstation, he can be provided Guest House accommodation free of cost for a period not exceeding 10 days in a stretch. However, the boarding charges shall be paid by the consultant as per actual.
