A written Examination is scheduled to be held for filling-up vacant posts of Junior Residents (Dental) on adhoc basis:

Interested candidates are requested to report on the date of written test with dully filled application form alongwith original documents as well as self attested copies of all certificates/documents. Candidates without application form and original documents are not allowed to appear in written test.

#### ELIGIBILITY CRITERIA

**Qualification:-** BDS degree from recognized university/institute. **Must not have completed one year Junior Residency in any Govt. institute/hospital in India on Regular/Adhoc basis.**

**Age:** For General Candidates 30 years as on date of written test relaxable for **OBC (Delhi only)** by 03 years..

**Pay Scale:** - Basic of Rs. 56100/- in Pay Matrix 10 of 7<sup>th</sup> CPC plus other allowances as admissible.

**Internship:** - Must have completed internship after 24.05.2024.

**K. Registration:** Candidates must have valid registration certificate of DCI/DDC/State Dental Council. **Application form without DCI/DDC/State Dental Council Registration Certificate or with 'Applied For' status shall not be considered.**

Result of the written examination will be displayed on the website of Health & Family Welfare and Indira Gandhi Hospital. No individual communication will be sent.

**Pattern of examinations:**

Written test will comprise of 50 multiple choice questions (MCQs). Negative marking will be done in MCQs. For every correct answer 04 marks will be allocated. For every wrong answer 1 mark will be deducted.

The duration of test will be 01 hour.

**General Instructions to the candidates:**

1. The candidate must report at the venue mentioned above between 09:30 AM to 10:30 AM.
2. No candidate will be allowed to enter in examination hall after 10:30 a.m.
3. Candidates must bring their one photo ID Card (Aadhar Card, Voter ID, Driving License or Passport) (in original). No other ID proof will be valid to enter in examination.
- 4. No mobile phone or interactive watches or any other electronic device will be allowed in the examination room. The candidates are advised to make their own arrangement for their belongings. The hospital will not make any arrangement and will not be responsible for any loss.**
5. Candidates must carry blue ball pen and transparent writing boards.
6. Candidates are not allowed to leave the examination room before completion of examination and without submitting the attempted question - answer sheet.


**CONDITION OF RECRUITMENT**

1. Selection criteria in case of same marks in written examination would be based on total percentage of marks obtained in Final Year of BDS. IN case of a tie in the marks scored in the written examination, the following criteria will be followed:-
  - (a) Candidate scoring higher marks in the final year BDS examination will be given preference.
  - (b) In case of a tie in the above, candidates with higher age will be given preference.
2. Final Selection/Joining is subjected to Original Documents verification. Candidature will be rejected if any discrepancy is detected at any stage of recruitment in documents/information given by the candidate.
3. The decision of the Selection Board/ Medical Director, IGH regarding selection will be final and binding and no representation will be entertained in this regard.
4. The appointment and services will be governed under Residency Scheme & MoH&W, Govt. of India.
5. All appointment shall be subject to **Medical Fitness**.
6. The service condition will be regulated as per the rules in the Residency Scheme, Ministry of Health & Family Welfare, Govt. of India of 1983.
7. No TA/DA & Accommodation for stay in Delhi will be paid/provided for appearing for written examination.
8. Appointment will be initially for a period of 89 days extendable upto maximum of one year or till the regular incumbent joins, whichever is earlier, on the basis of satisfactory work & conduct report form the concerned HoD and written request from the Doctor concerned.
9. The period for which a candidate has already worked in any Govt. Hospital as Junior Resident (Dental) will be deducted from the maximum period of one year of Junior Residency.




**Those who have already working for a period of one year in any govt. hospital are not eligible.**

10. Persons with disabilities shall be given relaxation as per rules.
11. Candidates are advised to ensure that they fulfil the eligibility criteria as mentioned in the advertisement before applying.
12. Other service conditions will be applicable as per service conditions prescribed from time-to-time by the GNCTD.
13. In case of any inadvertent error detected at a later stage the same will be rectified as per rules.
14. Jurisdiction of Dispute- in case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only
15. Competent Authority reserves right to decide in case of any dispute with regard to selection process.
16. Competent Authority reserves the right of any amendment or cancellation of the advertisement at any stage of recruitment.
17. **OBC certificate issued from Govt. of NCT of Delhi shall only be accepted.**
18. **OBC candidate must have Non-Creamy Layer Certificate (Delhi only) for the current Financial Year (2026-2027).**
19. **Outside Delhi OBC candidates will be treated in the UR Category.**
20.
