2. **DDC Registration:**
 - Candidates must be registered with Delhi Dental Council at the time of submission of application.

 - Candidates registration with State Dental Council other than delhi shall not be allowed for interview.
3. **Internship:** The candidate should have completed compulsory rotating internship after 20.08.2024.
