WALK IN INTERVIEW

Walk-in-Interview will be held at 9.00 a.m. on date mentioned below at National Institute of Plant Health Management, Rajendranagar, Hyderabad for engagement of following position on contractual basis. The engagement will be initially for a period of five months/ till project period whichever is later. The details of educational qualifications, experience, age and other eligibility criteria, along with **application proforma** are given below. The candidates desirous to apply for Field Staff shall carry all their educational credentials and attend for the walk-in interview.

The candidates attending walk-in interview should present themselves for certificate verification at the same venue by 9.00 a.m. on the dates mentioned in the notification. The candidates are directed to bring all the relevant original documents pertaining to educational qualifications/ experience in pest control activities / pest control in private company, etc., along with a set of self-attested photocopies and a recent passport size photograph, for necessary certificate verification. It may be noted that production of above said documents is mandatory. Failure to bring the same will render ineligible to attend Interview. No separate call letter for the Interview shall be issued. The position is purely temporary on contractual basis and co-terminus with the project or five month from the date of joining, whichever is later. NIPHM will not be held responsible to give regular appointment after expiry of the term. No TA/DA will be admissible for attending the interview.

DUTIES OF THE POSTS:

1	Field Staff (Rodent Control) - The Field Staff will be stationed at Nehru Zoological Park and report to the Asst. Curator daily He / she has to visit all the animal houses, aviary unit etc to collect the data on rodents and application of rodent traps , baiting etc in the animal house and field; Collect and disposal of dead rodents safely - Day to day reporting and submission of data to the PI, NIPHM - Any other duties assigned by the Zoo Authority and Division

GENERAL TERMS AND CONDITIONS:

1. The position is purely on contractual basis for a period of Five months/ Project Period whichever is later.
2. The continuance of Field Staff during the said period of Five months / project period depends on the satisfactory performance and availability of the budget for the project in which they have been engaged. It can be terminated at any time by issue of one month notice by NIPHM. It can also be terminated at any time without giving one months notice if he/she is found guilty of gross negligence or involved in acts of grave misconduct. The services of the Field Staff shall stand terminated automatically on expiry of the *contract* period unless it is extended in writing.
3. The candidates have to produce all the original certificates / experience certificate in any government body / in pest control company documents at the time of Interview for verification. Failure to bring the same will render ineligible to attend Interview.
4. No TA/DA will be admissible for attending the interview.
5. Self-attested copies of educational qualifications, Aaddhar card along with experience certificates are required to be submitted invariably.
6. Age and educational qualifications may be relaxed in exceptional cases by the Institute.
7. The Field Staff may also leave the assignment, on their own violation by giving one month notice period/ deposit 30 days pay in lieu of notice period or any short fall thereof or as decided by the Competent Authority of NIPHM. The decision of the Competent Authority will be final in this regard.
8. Regular attendance of them shall be ensured by the concerned official at Zoo / Director of the division keeping an attendance register/ biometric.
9. The Field Staff shall be engaged in the Scheme/Project work on full time basis and will not be allowed to undertake any other work or to accept or hold another appointment with or without remuneration elsewhere.
10. NIPHM and Zoo, Hyderabad will have full intellectual property rights/proprietary rights on research outputs of the Field Staff with reference to work done during the project period.
11. The Field Staff will be under the administrative control of the Director/ PI of the concerned Division at NIPHM / Curator of Zoo Park. He/ She shall have to work on all working days except for the General holidays and adhere to punctuality in attendance and should be willing to work before & after office hours in case of need. He/ She should be willing to work late hours, night shifts/ on holidays etc. as & when ordered by the competent authority as per the requirement of the work (emergency situation).
12. Their headquarters will be at Hyderabad (OR) will be as necessitated by the project.
13. The Field Staff will not be entitled to (i) General Provident Fund, (ii) NIPHM Group Insurance Scheme, (iii) All other service benefits allowed to regular employees. He/She will not be entitled to any travelling allowance at the time of joining and leaving NIPHM.
14. The Field Staff should stay within 3 km. radius of Nehru Zoological park, Hyderabad to be at ease to attend to office. In case of any deviation in this regard, the engagement will be terminated.
15. Field Staff will not be entitled to any Medical benefit & allowances.
16. The Field Staff shall have no claim, whatsoever, for regularization/absorption or otherwise against any regular post on termination of the tenure/project as it is purely contractual/temporary & is time bound in nature which runs co-terminus with the length of the project.
17. No correspondence will be entertained with the non-shortlisted or non-selected candidates.
