RECRUITMENT OF ASSISTANT PROFESSOR OF LAW

Tamil Nadu National Law University invites applications from eligible and qualified candidates for appointment to the post of **Assistant Professor of Law** on a **contract / ad hoc basis** for a period of **One (01) Year**. The details of the post are as follows:

ESSENTIAL QUALIFICATIONS:

As prescribed by the University Grants Commission (UGC) Regulations, 2018 for the post of Assistant Professor in Law. Candidates must fulfil the following minimum qualifications:

- Good academic record with a minimum of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) in Master's Degree in Law (LL.M.) from a recognized University.
- Besides fulfilling the above qualifications, candidates must have cleared the National Eligibility Test (NET) conducted by the UGC, or the State Level Eligibility Test (SLET/SET), or hold a Ph.D. Degree in accordance with the UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 as the case may be.
- Excellent written and verbal communication skills in English.

DESIRABLE QUALIFICATIONS:

- Demonstrable ability in high-level academic research and writing. Publication in high-impact peer-reviewed journals is preferred.
- Exposure to and/or interest in the management of learning difficulties.
- Preference will be given to those who have prior teaching experience.
- Professional or field experience in an area of interest will be positively viewed.
- The candidate must demonstrate a high degree of perseverance as well as drive to improve the academic and research culture at TNNLU.
