Note: i) Penalty for wrong/Multiple answers (Only for Part-I):-

- Total 90 nos. of MCQ type questions carrying 01(One) mark each and to be answered in OMR Sheet.
- There will be four alternatives for the answer to every question. For each question for which a wrong answer has been given by the candidate, **one-fourth** of the marks assigned to that question will be deducted as penalty.
- If a candidate gives more than one answer, it will be treated as a **Wrong Answer** even if one of the given answers happens to be correct and there will be same penalty as above to that question.
- If a question is left blank, i.e no answer is given by the candidate, there will be **no penalty** for that question.

ii) The answers are to be encoded in the OMR Answer Sheet by Black Ball Point Pen only.


Part-II (Conventional Type Question)

- iii) Total 02 nos. of Conventional type questions carrying 20(Twenty) marks each and to be answered in separate Answer Book.
- iv) The persons with benchmark disabilities will be allowed "Compensatory time" of 20 minutes per hour.
- v) The persons with benchmark disabilities and the condition mentioned at Para (IV) of Office Memorandum of Government of India F.No.34-02/2015-DD-III, dated:-29th August, 2018, intending to avail facility of **scribe** will have to inform the Commission at least 07(Seven) days prior to commencement of the examination.
- If a candidate fails to submit such representation at least 07(Seven) days prior to commencement of the examination, Commission will not be in a position to arrange **Scribe** for him/her.
- vi) The Provisional Admission Certificate will be available in the candidates Registration ID at least 7(Seven) days prior to commencement of the examination.

Provisional Answer Key of Written Examination (MCQ Part) will be uploaded on the website of TPSC within 1(One) month on completion of the Examination.

i. Mobile Phone/Electronic Gadgets etc. are banned in the campus of the Examination Premises/Interview Premises. Any Phone/Electronic Gadgets found in possession of any candidate in the Examination Premises/Interview Premises shall be confiscated forthwith and he/she may be debarred from appearing at the Examination/Interview and also for the Examination(s)/Interview to be conducted by the Commission in future.
