Terms and Conditions YP-I and YP-II (Young Professional I & II)


1. In case more number of applications candidates will be short listed on merit basis based on academic performance/ publications/ Experience etc. Only short listed eligible candidate will be interviewed by the selection committee in the ratio of 1:5.
2. The appointment is purely on temporary basis up to a period of six months w.e.f. date of joining or till termination of project whichever is earlier. However YP-I and YP-II (Young Professional I & II) appointed if found to be negligent in the project work; her/his appointment will be terminated without issuing show cause notice and assigning any reason.
3. YP-I and YP-II (Young Professional I & II) will not be entitled to claim any benefit or seniority by virtue of this order which is on purely temporary basis
4. He or she is bound by the rules and claims as provided in the University / ICAR AICRP (WIA) and will have no claim in the University / ICAR services
5. He or she should join the duty within ten days from the of date issue of this order as the work related to the targeted research objectives is in progress.
6. The YP-I and YP-II (Young Professional I & II) will be required to give an undertaking in the prescribed proforma on a court stamp paper of Rs. 100/- before joining that he or she will not leave the assignment half way and shall complete the project work in prescribed time limit. In case he or she need to resign or quit, he or she will have to tender one- month prior notice, failing which, he or she would remit one month consolidated amount in lieu of prior notice.
7. YP-I and YP-II (Young Professional I & II) will be bound to perform duties as directed by Competent Authority from time to time and shall carry out duties with due diligence and efficiency during period of contract.
8. The YP-I and YP-II (Young Professional I & II) shall hold in confidence and shall not disclose to any person any information, documents, official secrets from office record assigned to them and shall take due care to maintain the confidentiality of such information, documents, official secrets. They will be fully responsible for any disclosure or misuse of such information, documents and official secrets. The YP-I and YP-II (Young Professional I & II) will have to maintain utmost secrecy and confidentiality at all times as regard any information or knowledge obtained/ gathered during the said contractual period, and will not indulge in any activity prejudicial to the interest of the University.
9. It is agreed that during the aforesaid period of contract YP-I and YP-II (Young Professional I & II) will not undertake any private work, except after taking special permission from competent authority. If the competent authority is satisfied that such work affect the performance of duties and the same is against interest of state, the competent authority may refuse permission of such work. Despite such refusal of permission, if YP-I and YP-II (Young Professional I & II) accepts /continue to do private work, this appointment shall stand terminated and if any loss/damage is caused to the university due to such act of YP-I and YP-II (Young Professional I & II), he/she will be liable for action as per Law.
10. Even After termination of this agreement the YP-I and YP-II (Young Professional I & II) shall be bound to return all the office record, papers, documents, books or other material in its custody, to the Controlling officer.
11. Absence of the YP-I and YP-II (Young Professional I & II) at the work for more than 10 days without any sufficient cause would automatically account to termination of this contract without any notice or

intimation to the YP-I and YP-II (Young Professional I & II) by the Competent Authority and shall not be entitled for the remuneration for the said period of absence.

12. YP-I and YP-II (Young Professional I & II) will not leave the Headquarter or duty without prior permission of the competent authority during the period of contract.
13. As the work of AICRP - WIA focuses on collecting the information from different Agro-ecological zones of Maharashtra, through survey the YP-I and YP-II (Young Professional I & II) need to travel extensively outside the head quarter in different regions of Maharashtra. **The TA and DA will be given for the tours conducted by the YP-I and YP-II (Young Professional I & II) for conducting AICRP - WIA project work**
14. The eligible candidate should appear for Interview along with prescribed bio-data on dated 23.06.2026 at 11.00 hrs at Director of Research, VNMKV, Parbhani No TA/ DA will be admissible for attending the interview.
